- Chapter 20.08, Maui County Code, Relating to Soil Erosion and Sediment Control (LU-47) Amendment to Proposed Bill Relating to Soil Erosion and Sediment Control (PAF 18-002):

*The Soil & Water Conservation Districts strongly support **Amendment to Proposed Bill Relating to Soil Erosion and Sediment Control (PAF 18-002)**, with minor clarifying amendments:*

**20.08.080 Grading and grubbing permit review.** Drainage engineering slope hazard report, and erosion control plans shall be submitted to the applicable soil and water conservation district(s) and to the department of land and natural resources' state historic preservation division for review and comment. Applicants shall provide information sufficient to enable the reviewing agencies to determine that the proposed work will be in conformance with the most current standards **on file at the Department of Public Works** of the soil and water conservation district(s) and will meet the requirements of chapter 6E of the Hawaii Revised Statutes and related administrative rules. Final approval or disapproval **shall be made** by the County [~~shall be made~~] within ten days after receiving [~~their~~] the reviewing agencies' comments.

**20.08.160 Permit requirements**

Permittees shall comply with the state and county laws; the recommendations of the soil and water conservation district(s) **as approved by the County**; and the requirements of the department of land and natural resources' state historic preservation division.
