Chair and Members:

Your Government Relations, Ethics, and Transparency Committee, having met on June 7, 2023, and reconvened on June 9, 2023, makes reference to Resolution 22-250, entitled "AUTHORIZING SETTLEMENT OF CLAIM NO. 4072812 OF HALE MAHAOLU."

Resolution 22-250's purpose is to authorize settlement of the claim, filed on October 12, 2021, in the amount of \$208,185.57. The claim alleges damages to the claimant's property located at 200 Hina Avenue, Kahului, Maui, Hawai'i, resulting from flooding due to the failure of a drainage basin within Kahului Community Center Park.

By correspondence dated October 19, 2022, the Department of the Corporation Counsel provided a copy of the claim.

Your Committee notes Section 3.16.020(B), Maui County Code, requires Council authorization for any settlement of claims or civil litigation in excess of \$7,500.

A Deputy Corporation Counsel provided an overview of the claim and explained that the parties had reached a negotiated settlement, pending Council approval.

Based on information received and the recommendation of the Department, your Committee voted 7-0 to recommend adoption of Resolution 22-250. Committee Chair Uʻu-Hodgins, Vice-Chair Paltin, and members Johnson, Kama, Lee, Rawlins-Fernandez, and Sugimura voted "aye." Committee members Cook and Sinenci were excused.

- 2. That payment is authorized to satisfy settlement of this claim following the execution of the "Property Damage Release" by Hale Mahaolu; and
