Yesterday's GREAT meeting was productive, mahalo.
As I stated yesterday and as promised, attached is Exhibit D with those nominees Mayor has reviewed.

Prior to yesterday's meeting Mayor Bissen had reviewed Exhibit D and agreed there were qualified applicants listed, see blue highlights. Mayor was/is prepared to nominate some as either replacements for disapproved nominees or recommend them to the Independent Nomination Board to automatically fill vacancies for the "same" board or commission. That individual would be placed on the list the INB transmits to the appointing authority.

For example: Had the GREAT committee disapproved Randol Leach for Board of Ethics, Mayor was prepared to replace his nominee with Chivo Ching.
Since that is not the case, and the INB has a list of names for Board of Ethics vacancies for the Mayor he would add Mr. Ching to the list and nominate him to fill 1 of the 3 Vacancies currently for that Board.

Mayor feels it is in the best interest of our County to make our Boards and Commissions whole as soon as we can. All of the Boards have a lot of work to be done and quorum is key which can be accomplished, between his office, the Independent Nomination Board, and the work done by your Committee and Council working together.
