## RELATING TO THE APPOINTMENT OF LU ANN LANKFORD-FABORITO TO THE MOLOKAI PLANNING COMMISSION

WHEREAS, by correspondence dated October 24, 2017, Acting Mayor Mark R. Walker notified the Council that he nominated Lu Ann Lankford-Faborito to the Molokai Planning Commission for a term expiring on March 31, 2018, to fill a vacancy replacing Wiliama Akutagawa, pursuant to Section 2.28.020, Maui County Code, and Sections 8-8.4 and 13-2, Revised Charter of the County of Maui (1983), as amended, ("Charter"); and

WHEREAS, Charter Section 13-2, requires the Mayor's nominee to be approved by the Council; and

- 1. That it disapproves the appointment of Lu Ann Lankford-Faborito to serve on the Molokai Planning Commission for a term expiring March 31, 2018;
- 2. That the Council expresses its gratitude and appreciation to Lu Ann Lankford-Faborito for her willingness to be considered for public service and actively participate in County government; and
