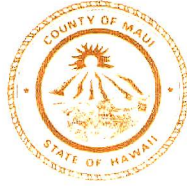

The purpose of the proposed bill is to amend Appendix A, Part I of the Fiscal Year 2023 Budget by adding a new grant entitled "USAgings Aging and Disability Vaccination Collaborative" for \$766,950. These funds will support the Maui County Office on Aging and its agency partners in providing COVID-19 and influenza vaccinations along with supportive services. In addition, the funds will provide the means for education and outreach regarding vaccinations targeted to older adults and people with disabilities, with a specific focus on diverse or under-served populations.
