EVERY SINGLE NIGHT THERE IS MEETINGS ALL DAY, ALL NIGHT, AND WE HAD A MEMO THAT SAID ALL COMMITTEE MEETINGS WERE SUSPENDED.\R\N\R\NWE HAD A PUBLIC HEARING WHEN THERE IS A 430 DEADLINE ON FRIDAY AND MONDAY AND A BINDER THIS THICK TO READ AND ANOTHER BINDER AND SOME PEOPLE SAY WE DON'T READ. WE ARE NOT GOING TO MAKE A DECISION TODAY, BUT I HAVE QUESTIONS AS WELL AND IF THEY DON'T COME UP WITH THE ANSWERS, THE COMMITTEE MEETING DURING BUDGET IS FURTHER WASTE OF OUR PART-TIME HOURS THAT WE ARE IN WORKING. YOU KOW, OVER THE COURSE OF THE PAST TWO YEARS, DOWLING CAME IN, LEFT, THERE WAS FOR SALE, RENTAL, THEN SOMETHING ABOUT A 201H. SO, I'M NOT EXACTLY SURE WHAT IT IS WE ARE EXTENDING? WHERE WE LEFT OFF ON ALL THE CHANGES OVER IF PAST TWO YEARS. I DO SUPPORT DEADLINES FOR THESE TYPE OF THINGS. WE HAVE A 201G IN WEST MAUITHAT PRECEDES 21H FOR DECADES AND WOULD FEEL BETTER IF WE BUILT THAT THING UT IT'S NOT GOING TO HAPPEN SOON.\R\N\R\NI'M SUPPORTIVE OF THE DEADLINE SO WE DON'T HAVE PROJECTS THAT MY GRANDKIDS ARE GOING TO TALK ABOUT THAT I APPROVED. I GUESS THOSE

WOULD BE MY QUESTIONS THAT I WOULD LIKE ANSWERED IF WE DO HAVE A SPECIAL SPECIAL MEETING ON A SPECIAL SPECIAL DAY, WHAT ARE WE EXTENDING BECAUSE THIS PROJECT HAS GONE THROUGH SO MUCH ITERATION AND WE KNOW ON THE NATIONAL LEDGE THAT THERE IS SO MUCH UNCERTAINTY, IF THERE IS GOING TO BE A RECESSION, IF INTEREST RATES ARE GOING TO DROP. THE BEST TIME WAS TO HAVE IT WHEN THE AFFORDABLE HOUSING FUND WAS HAPPENING AND NOW THERE IS NO AFFORDABLE HOUSING FUND AND THERE IS TARIFFS, ALL OF THESE THINGS. I DON'T KNOW THAT THIS IS A BETTER PROJECT IN ITS ITERATION BEFORE IT WAS APPROVED. THOSE ARE MY QUESTIONS THAT I HOPE THIS SEVEN DAY PRESENTATION WOULD ADDRESS. I GOT REALLY CONFUSED WHEN WE WERE GOING IF THE DOWLING SECTION AND DOWLING PULLING MONEY FOR THIS PROJECT AND THEN HAWAI'I CAME FOR THEIR MONEY AND IT'S OFF THE TABLE AND DIFFICULT TO KEEP UP WITH THIS PROJECT THAT HASN'T GONE ANYWHERE IN TWO YEARS.\R\N\R\N>>>> COUNCIL CHAIR ALICE LEE: THE 201G PROJECT, IS IT THE G PROJECT? >> YES. >> I WAS THERE WITH ABRAHAM LINCOLN. [LAUGHTER] >>COUNCILMEMBER GABE JOHNSON: WE ARE EXTENDING IT TO KEEP IT ALIVE. WILL IT BE BUILT NEXT MONTH? NO. WE NEED TO SCHEDULE IT SO WHEN WE DO HAVE TIME.\R\N\R\NTHAT MIGHT NOT ADDRESS THE CONCERNS. THIS IS TO KEEP IT ALIVE. AGAIN MEMBERS, I KNOW WE ARE ONE TEAM, ONE DREAM AND HOPE TO LOOK TO UNDERSTAND THE ISSUE RIGHT HERE TODAY IS DO WE WANT TO STEPPED IT EXTEND IT TO KEEP IT ALIVE. I'M PERTURBED THAT THIS DIDN'T COME TO US SOONER BECAUSE IT COULD HAVE. I THINK T SHOULD GO TO COMMITTEE AND US ASK ALL THESE 3 QUESTIONS BECAUSE HE SPOKE EARLIER THIS MORNING ABOUT THE THREE SOLUTIONS, HE TALKED ABOUT THE TWO OF THEM AND THIS ISSUE.\R\N\R\NI WILL TELL YOU THIS PROJECT IS A GREAT PROJECT. I GUESS MY FIRST QUESTION IS WHAT IS OUR FINANCIAL COMMITMENT BECAUSE THE REASON WE ARE BEING ASKED TO VOTE ON THIS IS BECAUSE THERE IS A FINANCIAL COMMITMENT BUT WE DON'T KNOW WHAT THE FINANCIAL COMMITMENT IS WHICH IS KIND OF ODD AND I SEE THE NAME CROSSED OFF HERE ON PAGE 5. AS FAR AS THE AGREEMENT. SO WHO WOULD BE THE ENTITY THAT, OR WHO WOULD BE SIGNING FOR THE COUNTY OF MAUI? WOULD IT JUST BE THE MAYOR, LIKE HOW? >> DIRECTOR?\R\N\R\N>> THANK YOU, CHAIR. . YES, I BELIEVE THIS AGREEMENT IS TO ALLOW THE MAYOR TO ENTER INTO THIS AGREEMENT. SORRY, IT'S REDUNDANT. IT WOULD BE THE MAYOR AT THIS POINT. >> I DO SEE WHERE THE MAYOR WOULD SIGN ON PAGE 5, THIS IS WEIRD. THERE IS A 5 AND A 5. SO THEN, IS THIS EVEN, IT'S NOT, IT LOOKS LIKE THE PAPERS ARE NOT UMBERED CORRECTLY BECAUSE THERE IS A PAGE 5 WITH A LOT OF MONEY. ARE WE REPLACING IT WITH A PAGE 5 WITH THE MAYOR'S SIGNATURE?\R\N\R\N>> THANK YOU, CHAIR. THANK YOU, COUNCIL MEMBER PALTIN. YES, THAT IS THE INTENT THAT THE OLD SIGNATURE PAGE. >> IT'S A LITTLE CONFUSING. I SEE THIS CROSS OFF BUT WHICH OF THE PAGES ARE WE -- >> I THINK CORP COUNSEL WANTS FOR CHIME IN HERE. >> CORP COUNSEL: THANK YOU. THIS HAS BEEN DISCUSSED WITH THE ADMINISTRATION FOR A LITTLE WHILE, AND AS YOU CAN SEE, FOR EXAMPLE, MITCH ROTH, IS NO LONGER THE MAYOR OF HAWAI'I COUNTY.\R\N\R\NIT HAS LINGERED FOR A WHILE. IT DOESN'T MATTER IF THE DIRECTOR OF OECD SIGNS. THAT MAY NOT BE TRUE FOR OTHER COUNTIES. MY STRONG RECOMMENDATION HOWEVER IS TO REFER THIS FOR FURTHER DISCUSSION AND CLEAN UP MOSTLY. NOT SO MUCH DISCUSSION. IT IS WHAT IT IS. BUT IF YOU HAVE SPECIFIC QUESTIONS ABOUT THE FINANCIAL OBLIGATION, THEY SHOULD ANSWER THOSE.\R\N\R\NBUT I WOULD LIKE TO SEE THIS A LITTLE BIT MORE CLEANED UP NOW THAT TIME HAS GONE BY THAT WE HAVE ENOUGH PLAYERS. THAT WOULD BE OUR DEPARTMENT'S RECOMMENDATION. THANK YOU. >> >> COUNCILMEMBER TAMERA PALTIN: THANK YOU. I'M DEFINITELY SUPPORTIVE OF CLEANING UP BECAUSE I DON'T WANT TO PUT MY NAME TO SLOPPY WORK. I GUESS SOME INFORMATION AT SOME POINT BEFORE I VOTE WOULD BE WHAT IS OUR FINANCIAL COMMITMENT, OR ALONG THOSE LINES BECAUSE THE ONLY REASON WE ARE VOTING ON IT IS BECAUSE IT HAS A FINANCIAL ASPECT BUT WE DON'T KNOW THE FINANCIAL ASPECT, I DON'T FEEL COMFORTABLE VOTING. >> COUNCIL CHAIR ALICE LEE: VICE CHAIR SUGIMURA?\R\N\R\N>> COUNCI MEMBER YUKI SUGIMURA: IT'S A GREAT DISCUSSION. WE CAN SEND IT TO MY COMMITTEE FOR CLEANING IT UP. >> MEMBERS, ANY

OBJECTION? >> NO. >> THANK YOU. NOW DOWN TO ONE. >> I BELIEVE THE DEPUTY IS ONLINE.\R\N\R\N>> >> COUNCIL CHAIR ALICE LEE: ALL RIGHT. MS. CLERK, CAN YOU BRING IT UP? >> THANK YOU, MADAM CHAIR. ANYTHING ELSE? >>CLERK: NO. >> LET'S MOVE ON TO THE LAST ITEM. >> RETURNING O 25-85. >> AMENDING RESOLUTION TO ALLOW THE DIRECTOR OF HOUSING TO EXTEND TIME DEADLINES FOR COMMENCEMENT OF CONSTRUCTION AND COMPLETION OF VILLAGE WORKFORCE HOUSING PROJECT.\R\N\R\N>> I DON'T HAVE ANY COMMENTS AND IN SUPPORT OF ALLOWING THE PROJECT TO EXTEND THE TIMELINES AND DEADLINES THAT WERE SPECIFIED. IN THE RESO THEIR MENTIONED AND IN RESOLUTION 25-85. I'M HERE TO ANSWER ANY UESTIONS THE COUNCIL IF YOU HAVE ANY. >> MEMBER PALTIN HAS THE QUESTION? >> WHAT IS THE RECOMMENDED EXTENSION, ONE YEAR, TWO YEARS? >> I THINK TWO YEARS WOULD BE THE RECOMMENDED EXTENSION FOR US. SO MOVING THE PREVIOUS DATES BY TWO YEARS WOULD BE APPROPRIATE FROM THE DEPARTMENT OF HOUSING'S PERSPECTIVE. SO, I DON'T KNOW IF WE HAVE IT IN HERE.\R\N\R\NI THINK WE HAVE IT IN THE WHEREAS CLAUSES AS OF MAY NINE, 2023 IS WHEN THE BILL PASSED. I BELIEVE WO YEARS TO START CONSTRUCTION FROM THAT DATE, AND A TWO ADDITIONAL YEARS TO COMPLETE CONSTRUCTION FROM 2025. IT WOULD BE A TOTAL OF 2027 WOULD BE WHEN WE WOULD BE REQUESTING CONSTRUCTION COMPLETION. >> YOU MEAN CONSTRUCTION INITIATED BY MAY 9, 2027, INITIATE CONSTRUCTION? >> CORRECT. >> THANK YOU, COUNCIL MEMBER, YES, THAT'S CORRECT. >> AND THEN COMPLETE BY MAY 9, 2032? >> I THINK 2029 WOULD BE THE TWO YEARS AFTER THAT. >> OH.\R\N\R\NOKAY. >> GOT IT. THANKS. >> YES, 29. >> COUNCIL CHAIR ALICE LEE: ANYMORE QUESTIONS FOR THE DEPUTY? WE HAVE MEMBER >>COUNCILMEMBER KEANI RAWLINS-FERNANDEZ: >> STAFF HAS JUST NOTED THAT IT WAS EFFECTIVE MAY 11, 2023. THANK YOU. >> >> COUNCIL CHAIR ALICE LEE: SO THE EXTENSION OULD BE? >> AS OPPOSED TO MAY 9. >> OKAY.\R\N\R\NALL RIGHT. WE HAVE MEMBER >> COUNCILMEMBER KEANI RAWLINS-FERNANDEZ: MAHALO, CHAIR. JUST ONE QUESTION FOR NOW TO DOVETAIL OFF MEMBER PALTIN'S QUESTION, THE SECOND TO THE LAST WHEREAS CLAUSE ON THE RESOLUTION DOES SAY THE TWO YEARS. IS THERE A REASON THAT A DATE WASN'T PUT THERE? TO MAKE THINGS CLEAR? >> THANK YOU FOR THE QESTION, COUNCIL MEMBER RAWLINGS FERNANDEZ. I DON'T HAVE AN ANSWER FOR THAT.\R\N\R\NI'M GLAD WE ARE HERE TO TALK WITH YOU FOLKS ABOUT INSERTING A DATE. >> GREAT. YOU WOULD SUPPORT PUTTING A DATE? >> YES. >> MAY 11, 2027. >> MAY 11, 2027, FOR THE INITIATION OF THE CONSTRUCTION AND MAY 11, 2029, FOR THE COMPLETION OF CONSTRUCTION. IT WOULD BE THE DEPARTMENT'S RECOMMENDATION. >> OKAY, MAHALO, DEPUTY DIRECTOR.\R\N\R\N>>>>CLERK: STAFF WOULD ALSO OTE THAT THE RESOLUTION 22193 PROVIDED TWO YEARS FROM AN EFFECTIVE DATE OF ORDINANCE 25-18 FOR THE START OF CONSTRUCTION BUT FIVE YEARS AS OPPOSED TO FOUR YEARS FOR THE COMPLETION OF THE PROJECT. >> OKAY. >> CHAIR? WILL YOU ASK MS. NAKATA TO HAVE THE DATES PREPARED IF WE WERE TO PUT ACTION ON THIS TO PUT IF DATE INTO THAT WHEREAS CLAUSE SECTION? >> MS. NAKATA, DUE HEAR THE REQUEST?\R\N\R\N>> YES, STAFF WOULD NEED THE INFORMATION TO PROVIDE AN ADDITIONAL TWO YEARS FROM WHAT WAS PREVIOUSLY DUE OR UNTIL, OR AN ADDITIONAL ONE YEAR. >> WE WOULD HAVE FOLLOWED THE ORIGINAL TIMELINE. EXCEPT NOW

- WE ARE CHANGING THE DATE. SO EVERYTHING WOULD MOVE ACCORDINGLY. >> CHAIR? >> THE WHEREAS CLAUSE READS; - WHEREAS IN LIGHT OF EVENTS PROPERTY LLC HAS REQUESTED AN ADDITIONAL TWO YEARS TO COMMENCE CONSTRUCTION ON PROJECT AND ADDITIONAL TWO YEARS TO COMPLETE THE PROJECT TO PROVIDE NECESSARILY FLEXIBILITY. FOR CLARIFICATION.\R\N\R\N>> COUNCIL CHAIR ALICE LEE: THEY ARE ASKING FOR TWO IN ADDITION TO WHAT THEY ALREADY WOULD HAVE GOTTEN. >> SO WOULD IT BE TWO YEARS ON TOP OF THE FIVE YEARS FROM 22193 OR TWO YEARS ON TOP OF THE FOUR YEARS INDICATED IN AN EARLIER WHEREAS CLAUSE. >> COUNCIL CHAIR ALICE LEE: LET'S ASK THE DEPUTY WHAT IS YOUR UNDERSTANDING? >> THANK YOU, COUNCIL CHAIR LEE FOR THAT QUESTION. THE INTENT HERE IS TO STICK WITH THE DATES THAT I HAVE IDENTIFIED. THE RECOMMENDATION IS WHAT WAS IDENTIFIED WHO YEARS FROM 2025, MAY 11, 2025, WHICH GETS US TO MAY 11, 2027. THAT GIVES THEM TIME TO INITIATE THE CONSTRUCTION. AND TWO YEARS FROM MAY 11, 2027, TO COMPLETE CONSTRUCTION WHICH WOULD GET US TO MAY 11, 2029. THAT'S THE DEPARTMENT'S RECOMMENDATION ON THIS RESOLUTION.\R\N\R\N>> MAHALO, DEPUTY. >> COUNCIL CHAIR ALICE LEE: IS EVERYONE OKAY WITH THAT? MEMBER COOK? >> COUNCI MEMBER TOM COOK: THANK YOU. I LIKE TO WEIGH IN AND I'M NOT IN AGREEMENT WITH TWO YEARS FOR THE CONSTRUCTION. IT'S JUST TOO MANY VARIABLES IN THE SUPPLY CHAIN AND EVERYTHING ELSE. THE TWO YEARS TO GET IT STARTED AND FIVE YEARS FOR CONSTRUCTION IS MORE PRAGMATIC AND PRACTICAL.\R\N\R\NI WOULD LIKE TO GET IT DONE SOONER, BUT TO BOXES A PROJECT IN THAT WE ARE REALLY IN SUPPORT OF AND ABBREVIATE THE COMPLETION TIME, I THINK YOU HAVE POTENTIALLY QUALITY ISSUES AND A LOT OF OTHER THINGS THAT YOU ARE RUSHING. MY PREFERENCE IS TWO YEARS EXTENSION TO GET IT STARTED, FIVE YEARS TO BUILD WHICH I BELIEVE WAS ORIGINALLY. AND A VERY FIRM NO MORE EXTENSIONS. >> OKAY. ORDINARILY I WOULD ASK FOR A MOTION BUT I WOULD RATHER NOT BECAUSE THERE IS STILL A LOT OF QUESTIONS IN THE AIR. SO WE'LL GET TO THE MOTION SOON. MEMBER PALTIN AND THEN MEMBER JOHNSON. >> COUNCILMEMBER TAMERA PALTIN: THANK YOU, CHAIR.\R\N\R\NI DON'T NECESSARILY HAVE A PROBLEM WITH MEMBER COOK'S RECOMMENDATION, BUT I WOULD LIKE TO HEAR FROM THE DEPARTMENT ON THE RATIONAL FOR NOT STICKING WITH THE 2/5 THAT WAS ORIGINALLY PASSED AND THEIR REASON FOR GOING WITH THE 2/2. I REMEMBER WHEN I FIRST CAME ON THE COUNCIL AND SAID WHAT IF THEY GET THE ENTITLEMENTS AND DON'T FINISH WITHIN THE FIVE YEARS OR WHATEVER THE ALLOTTED TIMEFRAME WAS, I UNDERSTAND THAT WE CAN GIVE THEM AN EXTENSION DURING CONSTRUCTION. THE MAIN CONCERN IS THE BEGINNING OF CONSTRUCTION AND NOT NECESSARILY THE ENDING OF CONSTRUCTION. BECAUSE IF THEY ARE IN THE MIDDLE OF BUILDING HOUSING AND THEY MISS THEIR ENDING CONSTRUCTION DATE, I DOUBT AT THAT POINT WE WOULD JUST SAY, LEAVE THE HOUSES HALF COMPLETED AND WALK AWAY. BUT I'M OPEN TO HEARING FROM OUR DEPUTY DIRECTOR AS TO THEIR RATIONAL FOR THE RECOMMENDATIONS ON TIME. >> DEPUTY DIRECTOR? >> THANK YOU FOR THE QUESTION, COUNCIL MEMBER PALTIN. AND TYPICALLY WHAT WE HAVE SEEN IS ONCE YOU START CONSTRUCTION, IT PRETTY MUCH COMPLETES WITHIN TWO YEARS.\R\N\R\NSO, IT LEAVES THE DOOR OPEN THAT FOR YOU FOLKS THAT WE CAN ALWAYS COME BACK FOR ANOTHER EXTENSION IF WE HAVE TO. I DON'T WANT TO GET TO THAT POINT BUT WHAT WE HAVE EEN FOR PROJECTS WHEN THEY START CONSTRUCTION THAT ALIGNS WITH CLOSING THEIR FINANCES AND MOVING FORWARD THAT TWO YEARS SEEMS REASONABLE ONCE YOU START CONSTRUCTION TO MOVE FORWARD. COUNCIL MEMBER DOES BRING UP A GOOD POINT THAT

THERE ARE A LOT OF EXTERNAL FACTORS THAT WE HAVE TO CONSIDER. IF ALL THE DUCKS ARE IN A ROW TO START CONSTRUCTION AS FAR AS FINANCING GOES, THEY SHOULD HAVE ENOUGH TIME TO COMPLETE CONSTRUCTION BARRING ANYTHING CRAZY THAT MAY OR MAY NOT HAPPEN. >> IF THE CAZY, MAY OR MAY NOT HAPPEN, THE SOLUTION WE HAVE AVAILABLE TO OFFSET THAT TIME WOULD BE THE EXTEND THE FINISH TIMELINE? >> THANK YOU FOR THE QUESTION, - COUNCIL MEMBER PALTIN, YES. WE CAN ALWAYS COME BACK TO COUNCIL IF THERE IS SOME EXTENUATING CIRCUMSTANCE WHERE THEY CAN'T COMPLETE THE CONSTRUCTION WHERE WE MAY ASK FOR ANOTHER EXTENSION FROM COUNTY COUNCIL.\R\N\R\N>> BY THAT TIME, THE DEPARTMENTAL HOUSING SHOULD BE SO WELL-SET UP THAT PEOPLE WOULDN'T PUT IN OUR EQUEST IN SEPTEMBER AND WE EAR IT IN MARCH, RIGHT? >> THAT'S CORRECT. >> OKAY. JUST VERIFYING. >> MEMBER JOHNSON AND THEN MEMBER COOK. >> >>COUNCILMEMBER GABE JOHNSON: THANK YOU. I WOULD LIKE TO HEAR FROM THEM.\R\N\R\N> WE ARE GOOD WITH WHATEVER THE BILL OF THE BODY IS. >> THE WILL OF THE BODY IS FOR YOU TO GET STARTED. WE NEED HOUSING AS SOON AS POSSIBLE. THANK YOU FOR THAT RESPONSE. THANK YOU, CHAIR. MEMBER COOK? >> COUNCI MEMBER TOM COOK: I DON'T HAVE ANY PROBLEM WITH REVERSING WHAT I PREVIOUSLY SAID WITH WHAT THE HOUSING DEPARTMENT SAID AND THE COUNCIL HAVING THE LATITUDE TO APPROVE IT AS NECESSARY IS FINE.\R\N\R\N>> COUNCIL CHAIR ALICE LEE:. ALL RIGHT. MEMBER PRO TEM KAMA? >>COUNCILMEMBER TASHA KAMA: I HAVE A QUESTION. HOW MUCH ADDITIONAL MONEY DO YOU NEED TO MAKE THE PROJECT? >> THANK YOU FOR THE QUESTION, MEMBER KAMA. I THINK, I'M GOING TO KEEP IT SHORT. WHERE WE ARE AT CURRENTLY, IS WE HAVE REACHED BACK OUT TO THE DOWLING COMPANY TO TRY TO WORK ON THIS PROJECT BECAUSE RIGHT BELOW THIS PROJECT THEY ARE PUTTING IN THIS PHASE 2 OF DHHL HOMES.\R\N\R\NTHEY ARE GOING TO BE MOBILIZED, ALREADY THERE AND WORKING AND COULD THEY JUST MOVE NORTH? WE HAVE BEEN TALKING TO EVERETT AND HIS TEAM AND THEY ARE VERY VERY CLOSE TO HAVING ALL OF THEIR DUCKS IN A ROW AND THAT IS TO ANSWER MEMBER PALTIN'S OUESTION. I REACHED OUT TO EVERETT. HE IS A VERY BUSY INDIVIDUAL BUT HE'S ACTUALLY ON THE LINE RIGHT NOW. I DON'T WANT TO SPEAK TO HIS PRODUCT. IF YOU DON'T MIND, I WOULD HAVE MAYBE EVERETT SPEAK TO WHAT IT - IS THEY ARE DOING. >> THE QUESTION WAS HOW MUCH ADDITIONAL MONEY DO YOU NEED TO MAKE YOUR PROJECT CANCEL?\R\N\R\N>> EVERETT WOULD KNOW THAT OUESTION BETTER THAN I BECAUSE HE IS THE ONE THAT IS DOING THIS WHAT'S COMING. AS IT SITS NOW IS ABOUT \$35 MILLION IS WHAT WE NEED. >> PRO TEM KAMA, DO YOU WANT TO SPEAK TO MR. DOWLING? >> NO, I HAVE OTHER QUESTIONS. DO YOU NEED TO CHANGE THE NATURE OF YOUR PROJECT TO GET IT CLOSE TO CANCELING OUT? >> YES, MA'AM.\R\N\R\N>> HOW MUCH OF A CHANGE? >> REDUCING THE NUMBER OF UNITS AND THE MIX OF UNITS. IT'S CURRENTLY SEVEN DIFFERENT HOME TYPES AND 54 BUILDINGS, PROBABLY REDUCING IT TO HALF AND MAKING IT MORE OF A SINGLE-FAMILY AND DUPLEX PRODUCT. >> DO YOU HAVE ALL THAT LINED UP TO GO? >> WE ARE EFFORTING THAT RIGHT NOW. >> OKAY. ONE MORE.\R\N\R\NWOULD ANY CHANGES IN THE TYPE OF NATURE OF THE HOUSING UNITS PROPOSED ESSENTIALLY INVALIDATE THE ENTITLEMENT THAT YOU HAVE? >> WE DO NOT BELIEVE SO, WE FEEL IT'S IMPORTANT TO WORK WITHIN THE PARAMETERS OF THE CURRENT ENTITLEMENTS THAT WE HAVE TO NOT HAVE TO RESET THE PROCESS ALL OVER AGAIN AND COST US TIME. >> OKAY. THAT'S ALL MY QUESTIONS. >> >> COUNCIL CHAIR ALICE LEE: DID YOU HAVE QUESTIONS FOR SOMEBODY ELSE? >> NO. >> OKAY.\R\N\R\N>> MEMBER PALTIN AND

THEN VICE-CHAIR SUGIMURA. >> COUNCILMEMBER TAMERA PALTIN: THANK YOU. FOR MR. CARNOTELI. AT ONE TIME IT WAS FOR SALE AND THEN I HEARD TALKS ABOUT RENTAL. CAN YOU GO DOWN HOW MANY UNITS YOU ARE PROPOSING, AND ALL OF THOSE SPECS, IS IT POSSIBLE? IS IT FOR SALE, THE PRICE POINTS.\R\N\R\NWAS THAT PART OF THE BILL SO IT CANNOT CHANGE OR IT CAN CHANGE? >> THANK YOU, MEMBER PALTIN. THE ENTITLEMENTS THAT WE WERE GRANTED WERE 2.97 WHICH IS 100% WORKFORCE HOUSING. IT IS A SHORT SALE PROJECT, FOR SALE PROJECT FROM 80% AMI TO 140% OF AMI. IT IS A MIXED USE, SEVEN DIFFERENT HOME TYPES, 54 BUILDINGS. THAT'S WHAT THE ENTITLEMENTS ARE. WHAT'S BEFORE US TODAY IS WHAT YOU GRANTED BEFORE UNANIMOUSLY AND JUST GIVE US AN DDITIONAL TWO YEARS TO BE ABLE TO INITIATE.\R\N\R\N>> SO, JUST CLARIFYING, 100% FOR SALE, 80% TO 140% A.M.I. WAS THERE A DECOMPRESSION IN THE BILL? >> IT IS A TEN YEAR DEED RESTRICTIONS AND ALSO AN OWNER OCCUPIED IN PERPETUITY TO THE COMPONENT IN THE DEED RESTRICTION. >> WAS THERE A PRICE POINT GUARANTEE OR NO? >> NO. IT'S JUST ASKING FOR THE CODE. >> FOR THE PREVIOUS FUNDING OR NOT AT ALL? >> NO.\R\N\R\NIT'S JUST AS PER THE CODE. >> OKAY. SO JUST TO CLARIFY, IF WE GRANT THE EXTENSION, ALL OF THOSE THINGS THAT YOU SAID, 2.97 WORKFORCE HOUSING 80-140% AMMI? >> THAT'S CORRECT. >> IT MAY NOT BE EXACTLY 220 UNITS UT STILL CONFORMING TO WHAT THE APPROVALS ARE. I THINK YOU HAVE TO TALK TO THE DEPUTY DIRECTOR OR DIRECTOR AS FOR WHETHER OR NOT WE HAVE TO COME BACK TO YOU FOR APPROVALS OF WHAT THE CHANGE MIGHT BE. >> IF IT'S NOT 202, ARE YOU THINKING OF MORE HOMES OR LESS HOMES?\R\N\R\N>> IT WOULD ONLY BE LESS, NEVER BE MORE. >> OKAY. THANK YOU. >> COUNCI MEMBER YUKI SUGIMURA: THANK YOU. I AGREE WE WANT THIS PROJECT TO HAPPEN. THANK YOU VERY MUCH. WHAT I WILL ASK IS ABOUT THE FUNDING.\R\N\R\NWHAT DOES YOUR INANCIAL STACK LOOK LIKE? TODAY. >> TODAY THERE IS A SHORTFALL OF \$35. MILLION. WE HAVE TALKED TO HHFDC ABOUT YOU MENTIONING THE FUNDS AND DIFFERENT FUNDS HAPPENING AT THE LEGISLATURE NOW AND THERE IS AN URGENCY ON THAT END. THEY ARE LOOKING AT AN ASPECT OF WHAT YOU SAID. FOR THE LOAN, THERE WOULD BE FUNDING, BUT THERE WOULD BE THE AMOUNT THAT WAS FUNDED WOULD COME BACK UPON RESALE. >> IT STILL DIDN'T PASS THE LEGISLATURE SO WE ARE STILL WATCHING.\R\N\R\NDO YOU HAVE WATER? >> YES, WE DO. >> YOU HAVE ACCESS TO WATER AS LONG AS YOU KEEP THE 2.97? >> CORRECT. >> OKAY. >> I HEARD THAT WAS QUESTIONABLE. IS THAT CORRECT, DEPARTMENT? DOES THIS PROJECT HAVE WATER?\R\N\R\N>> DEPUTY DIRECTOR? >> THANK YOU FOR THE QUESTION, COUNCIL MEMBER SUGIMURA. THAT WOULD BE A QUESTION FOR THE DEPARTMENT OF WATER SUPPLY WHETHER IT HAS WATER OR NOT. >> OKAY. HOW DO YOU DEAL WITH THAT? CAN WE CALL THEM AND ASK THEM? BECAUSE THAT'S KIND OF HUGE.\R\N\R\N>> I THINK WE ALREADY APPROVED THAT PROJECT. WE ARE JUST TALKING ABOUT THE TIME EXTENSION. IF THEY HAVE PROBLEMS WITH THE PROJECT GOING FORWARD, THEY ARE GOING TO HAVE TO COME BACK TO US. >> OKAY, IS MR. DOWLING ON THE CALL? I HEARD MR. CAN CHELLY SAYING MR.\R\N\R\NDOWLING WAS ON THE CALL. >> MR. DOWLING, ARE YOU THERE? >> HI. THANK YOU VERY MUCH. WE CAN HAVE HIM AS A RESOURCE. >> WE HAVE MANY PEOPLE ALREADY.\R\N\R\NWHAT'S ANOTHER ONE? >> MR. DOWLING. MR. CAIN CHELLY CAN ASK YOU BUT HE SAYS YOU MAY TAKEOVER THE PROJECT? >> COUNCIL MEMBER SGIMURA, YES, WE ARE LOOKING AT IT NOW. IT'S BEEN A CHALLENGING FUND PUZZLE TO PUT TOGETHER.\R\N\R\NAS HAS BEEN MENTIONED BEFORE, WE ARE DOING THE DHHL PROJECT IMMEDIATELY ADJACENT TO THIS. WE HAVE LOOKED AT FIVE DIFFERENT PRODUCT TYPES. WE HAVE RUN A NUMBER OF SITE

PLANS AND ENGINEERING AND DIFFERENT PROJECT TYPES. WHERE WE ARE NOW IS 50 DUPLEX. 100 UNITS, AND 50 BUILDINGS, PLUS SIX ADA UNITS. SO 106 UNITS. NOW, WE ARE TRYING TO GET THE PUBLIC ASSISTANCE TO ASK FOR \$35 MILLION TO THE NEIGHBORHOOD OF \$15 MILLION. IT WOULD REQUIRE LESS WATER, HAVE LESS IMPACT THAN THE REQUIRED PROPOSAL AND MORE EFFICIENT TO BUILD.\R\N\R\NIT'S JUST HAVING BASICALLY TWO PRODUCT TYPES TO BUILD AND REALLY THE BULK OF THAT IS SIMILAR PRODUCT TYPE. IT MAKES IT MORE EFFICIENT TO BUILD AND GIVES US THAT ABILITY AND LOWER UNIT COUNT TO REDUCE THE SHORTFALL AND OUR TARGET SHORTFALL IS \$15 MILLION AND AS MENTIONED, IT WOULD BE A FOR SALE PRODUCT. >> OKAY. SO THEN IT'S NO LONGER AT 2.97 PROJECT. DID I MISUNDERSTAND? >> I BELIEVE IT WAS ALWAYS REPRESENTED AS A FOR SALE PRODUCT. >> I THOUGHT IT WAS A WORKFORCE DEVELOPMENT PROJECT?\R\N\R\N>> IT IS WORKFORCE HOUSING PRICES. >> OH, THE PRICING. SO YOUR SHORTFALL IS NOW \$50 MILLION VERSUS WHAT WAS PROJECTING AT \$35 MILLION. SO HOW DO YOU -- >> THAT'S OUR TARGET SHORTFALL. THAT IS WHAT WE ARE WORKING TOWARDS BASED UPON THE IN PUT THE THAT WE HEARD FROM HHFDC REGARDING THE FUNDING. >> SO THE 15 MILLION WILL COME FROM THE DERF FUNDING? >> WE ARE HOPING IT COMES PARTIALLY ROM THE COUNTY AND HDFC.\R\N\R\N>> IF THIS WILL BE IN THE RESO AND BY 2027 YOU HAVE THIS RESOLVED SO CONSTRUCTION CAN COMMENCE? >> RIGHT. >> 2027, IS THE DATE. >> WILL YOU BE ABLE TO PUT THE PIECES TOGETHER? >> CORRECT. >> OKAY, DONE, FOR ME. >> >> COUNCILMEMBER TASHA KAMA: MR.\R\N\R\NDOWLING. DID YOU SAY AT SOME POINT YOU MIGHT COME BACK TO THE COUNTY FOR FUNDING? >> WE ARE ABOUT TWO WEEKS WITH A YOU FROM HAVING OUR SUB CONTRACTOR PRICING. WE RECEIVED PRICING ABOUT A WEEK 1/2 GEO. AND WE NOTICED SOME OF THE PRICING, SOME OF THE LINE ITEMS STRUCK US AS RATHER HIGH, SO WE ASKED THE CONTRACTOR TO GO BACK TO WHERE THEY GOT THE ORIGINAL PRICING FROM AND COME BACK WITH A REVISED LOWER COST TO CONSTRUCT THE UNITS. WE ANTICIPATE HAVING THE PRICING BACK FROM A WEEK FROM TODAY. WE HOPE BY THEN TO QUANTIFY WHERE WE ARE IN TERMS OF THE SHORTFALL AND SOLVE FOR THE SHORTFALL ONCE WE COLLECT ON THE QUANTIFIED.\R\N\R\NWE ARE HOPING IT'S NOT GOING TO BE MORE THAN THE \$15 MILLION RANGE. AND THE FUNDING TO BE AVAILABLE FOR THE PROJECT WHEN IT COMES BACK TO THE SOLD WHEN IT'S SOLD BY THE ORIGINAL BUYER. >> OKAY. MY LAST QUESTION. THE DEPARTMENT OF HAWAIIAN HOMELANDS HAS DEVELOPMENT A WATER PLAN TO BUILDUP COUNTRY TO RUN THE WATER TO SOUTH MAUI AND THEN RUN IT BACK OVER TO THE DHHL PROJECTS ON THE WILLEKAU SIDE? >> CORRECT. >> SO SOME OF THAT WATER IS FOR THIS PROJECT?\R\N\R\N>> NO, THOSE WELLS WILL SAFE THE USE FOR THE PROJECT. AND ONE DHHL PROJECT IN SOUTH MAUI. >> OKAY, THAT'S ALL THE QUESTIONS I HAVE. >> OKAY, WE ARE GOING TO BE VOTING ON IT ANY SECOND NOW. >> COUNCILMEMBER KEANI RAWLINS-FERNANDEZ: MAHALO, CHAIR. LIKE MEMBER SUGIMURA, I REMEMBER THAT THIS PROJECT BEING PROPOSED AS A RENTAL PROJECT, AND THAT WAS NOVEMBER 1, 2023. THE PROJECT WAS GOING TO MAKE ORIGINALLY 202 HOUSES FROM TINY HOMES AND DUE TO HIGH INTEREST RATES, THE LAND OWNER SAYS IT'S NO LONGER FEASIBLE AND NOW FROM AN OWNER MODEL TO RENTAL MODEL. I DON'T UNDERSTAND WHY YOU SAID IT WAS NEVER A RENTAL MODEL BECAUSE THAT WAS PRESENTED IN 2023? >> IF I MAY CLARIFY MY STATEMENT.\R\N\R\NI BELIEVE AS ORIGINALLY PRESENTED IT WAS A FOR SALE PRODUCT. AND APPROVED FOR A FOR SALE PRODUCT. IN 2023, WE LOOKED AT THE TIME WE WERE APPROACHED WE LOOKED AT CONVERTING THAT TO A RENTAL PROJECT, AND NCE AGAIN WE

ARE TRYING TO SOLVE TO GET THE PUBLIC ASSISTANCE DOWN SO THAT DID NOT WORK. IT DID NOT MOVE THE NEEDLE IN ENOUGH TO MAKE IT A VIABLE PROJECT SO WE ARE LOOKING AT A FOR SALE PRODUCT. >> THAT'S WHY SOME OF THE COUNCIL MEMBERS ARE ASKING. THERE HAVE BEEN SO MANY PRESENTATIONS. I DON'T EVEN KNOW, I SEE MR.\R\N\R\NCARNEY CHELLY ON THE PROJECT AND HE CORRECTED ME. IT'S NOT CLEAR. IF IT'S NOT CLEAR FOR US, IT'S DEFINITELY NOT CLEAR FOR THE PUBLIC, AND WE DEFINITELY NEED TO HAVE A DISCUSSION. I THINK I WOULD BE OKAY WITH EXTENDED THE DEADLINE, I DON'T KNOW IF WE PUT A CONDITION. I WOULD LIKE TO KNOW WHAT THE PROJECT IS, AND MAYBE YOU CAN CLEARLY STATE IT TODAY AND THAT WOULD BE GREAT. >> COUNCIL CHAIR ALICE LEE: WE HAVE A COUPLE OF PEOPLE THAT WISH TO SPEAK. NOW BEFORE MR.\R\N\R\NDOWLING ANSWERS. CORP COUNSEL, DO YOU WANT TO TAKE IT UP NOW. >> CORP COUNSEL: VERY QUICKLY, I HOPE THIS ADDS CLARITY. THE ORIGINAL AGREEMENT HAD ALL THE REPRESENTATION AND SPECS ON WHAT YOU FOLKS APPROVED. THE LAW IS CLEAR THAT IF THERE ARE SUBSTANTIAL CHANGES TO THAT, THEY MUST COME BACK TO YOU. SO I DON'T KNOW THAT YOU REALLY NEED TO PLACE CONDITIONS TODAY ON THAT. THEY CANNOT PROCEED WITH A SUBSTANTIALLY DIFFERENT PROJECT WITHOUT YOUR APPROVAL, FURTHER APPROVAL FROM THAT.\R\N\R\NI THINK MR. CARNEY CHELLY WAS TRYING TO MAKE THAT POINT THAT YOU HAVE THAT ASSURANCE THAT THIS PROJECT CANNOT MORPH INTO SOMETHING YOU DID NOT APPROVE. >> CHAIR, COULD SHE REPEAT IF RESO NUMBER? >> THE CURRENT RESOLUTION 22-193C 1. >> COUNCIL CHAIR ALICE LEE: DEPUTY DIRECTOR WANTED TO SAY SOMETHING QUICKLY TOO. >> THANK YOU, CHAIR. I DIDN'T REALIZE THAT FIRST DEPUTY CORP COUNSEL LSO HAD HER HAND UP. I WAS GOING TO REPEAT THAT WHAT YOU ARE APPROVING TODAY IS THE ORIGINAL XTENSION AS PROPOSED.\R\N\R\N>> NOT THE DESIGN OF THE PROJECT. RIGHT. >> OKAY, DID YOU WANT MR. DOWLING TO RESPOND EVEN THOUGH YOU HAVE RESPONSES FROM TWO OTHER PEOPLE? >> >>COUNCILMEMBER KEANI RAWLINS-FERNANDEZ: YES. PLEASE. MAHALO.\R\N\R\N>> MR. DOWLING? >> WE ARE HAPPY TO COME BACK. WE LOOK FORWARD TO COMING BACK. AND SHOWING YOU WHAT THIS PROJECT IS AND SHOWING YOU THE COMPARISON OF THE ORIGINAL PRESENTATION THAT WAS MADE YEARS AGO AND WHAT WE HAVE COME UP WITH. >> SO IT'S THE 202 RESIDENTIAL WORKFORCE HOUSING UNITS FOR SALE THAT'S THE MIXED USE, THAT'S THE TINY HOMES AND THAT ORIGINAL ONE? >> THAT WAS THE ORIGINAL PROPOSAL, ORIGINAL PRESENTATION THAT THE PROJECT WAS APPROVED UPON, YES.\R\N\R\N>> WHAT WE ARE CURRENTLY LOOKING AT IS 50 DUPLEXED WHICH EQUATE TO 100 UNITS PLUS SIX ADA UNITS IN ADDITION TO THE DUPLEX UNITS, THE ADA UNITS RE SINGLE-FAMILY DETACHED. >> OKAY, THAT'S CLEAR TO ME NOW. MAHALO CHAIR. MAHALO, MR. DOWLING. >> THANK YOU. >> MEMBER PALTIN?\R\N\R\N>> COUNCILMEMBER TAMERA PALTIN: THANK YOU. I JUST HAD A QUESTION IN RELATION TO THE TWO DEPUTIES WHAT THEY WANTED TO SEE. WHAT IT COMES DOWN FROM 54 BUILDING SEVEN HOME TIMES TO 50 DUPLEXES PLUS SIX DA, A CHANGE OF 202 TO 106, IS THAT CONSIDERED A SUBSTANTIALLY DIFFERENT THING THAT IF WE GRANT THIS EXTENSION THEN WE HAVE TO GO BACK AND AMEND THE ORDINANCE OR SOMETHING? >> MM-HMM. >> WHOEVER KNOWS THE ANSWER? >> THE ANSWER IS YES. >> YOU CAN HEAR IT FROM CORP COUNSEL TOO.\R\N\R\N>> CORP COUNSEL: THANK YOU, CHAIR. THE ORIGINAL RESO STATES THE FINAL SPECS WILL BE APPROVED UNLESS DEVIATED BY THE OFFICE OF HOUSING, OUR DEPARTMENT WOULD CONSTRUE THAT AS A SUBSTANTIAL DEVIATION AND RECOMMEND THE DIRECTOR SUPPORT BRINGING THAT BACK TO YOU FOR ADDITIONAL DISCUSSION. >> THANK YOU. AND

THEN I HAVE SEEN MS. DEPUTY MAUKA OFFER HIS HAND AS WELL. >> DEPUTY?\R\N\R\N>> THANK YOU, CHAIR. AND COUNCIL MEMBER PALTIN. WE WOULD LIKELY MAKE THE SAME DETERMINATION THAT IT WOULD NEED TO COME BACK FOR COUNCIL REVIEW IF IT CHANGES. >> OKAY. I THINK I HAVE HEARD ALL THE INFORMATION. THE KEY CLENCHER FOR ME TO SUPPORT AN EXTENSION IS THAT THIS IS WORKFORCE HOUSING FOR SALE OWNER OCCUPIED IN PERPETUITY, SO OUR WORKFORCE WILL OWN THE HOME AND SELL IT TO THOSE WHO WILL STILL OWN THE HOME BUT UNFORTUNATE THAT IT WILL NOT BE AT WORKFORCE HOUSING PRICES. MY KNOWLEDGE THAT THE AREA IS IT'S LESS OF A TRANSIENT POPULATION THAN SAY SOUTH AND WEST MAUI.\R\N\R\NSO I DON'T THINK THE AFFORDABILITY COMPONENT WOULD GET AS OUT OF CONTROL AS IT DOES IN MY DISTRICT AND MEMBER COOK'S DISTRICT JUST BECAUSE A LOT OF OUR WORKFORCE LIVES HERE. THERE IS A LOT OF GOVERNMENT JOBS AVAILABLE. SO, I AM SUPPORTIVE OF THE EXTENSION PRIMARILY DUE TO 100% WORKFORCE HOUSING OWNER OCCUPIED FOR SALE IS WHAT I HAVE HEARD PEOPLE WANT. I KNOW THAT WE DO A LOT OF RENTALS AND I'M NOT PPOSED FOR THAT. BUT I THINK WE HAVE TO DO SOME FOR SALE AND THE COMPONENT OF OWNER OCCUPIED IN PERPETUITY MAKES ME WILLING TO TAKE THIS STANCE. >> COUNCIL CHAIR ALICE LEE: OKAY. ARE YOU READY TO VOTE?\R\N\R\N>> LET'S VOTE. >> EXCUSE ME, CHAIR. COULD STAFF ASK WHETHER IT'S OKAY TO READ INTO THE RECORD THE REVISED RESOLUTION TO MAKE SURE WE HAVE ALL THE AMENDMENTS? >> I BELIEVE THERE ARE A NUMBER OF REVISIONS MADE TO THE RESOLUTION. >> ONLY THE DATE ROM THE NINTH TO THE 11TH, AND THE YEAR. >> THERE IS A NUMBER OF TECHNICAL REVISIONS THAT ARE ALSO NECESSARY, CHAIR.\R\N\R\NAND NORMALLY WE WOULD LIKE TO WRITE THAT UP IN A FORMAL ASF, BUT BECAUSE OF THE UNANTICIPATED FLOOR ACTION, WE DIDN'T HAVE A CHANCE TO DO THAT. THAT IS OUR SUGGESTION FOR TRANSPARENCY AND CLARITY TO HAVE THE RESOLUTION READ INTO THE RECORD. BUT IT'S THE BODY'S PREFERENCE. >> LET'S DO IT FOR TRANSPARENCY. >> OR SHOULD WE TABLE THIS TO THE NEXT COUNCIL MEETING. >> OKAY, MAKE IT CORRECT. >> ALL RIGHT.\R\N\R\N>> YES. >> OKAY, EVERYBODY? >> YEAH. >> BECAUSE WE ARE NOT GOING TO DO IT NOW. I WILL TELL YOU RIGHT NOW. IF WE CAN HAVE THE STAFF FIX IT BY THE NEXT COUNCIL MEETING. I'M SORRY.\R\N\R\NMEMBER FERNANDEZ? >> COUNCILMEMBER KEANI RAWLINS-FERNANDEZ: I SUPPORT YOUR RECOMMENDATION. WOULD IT BE A PROCEDURE WITH AN AFS TO AMEND THIS BILL ONE FINISHED BUSINESS R A NEW RESOLUTION IN ITS ENTIRETY. >> COUNCIL CHAIR ALICE LEE: LET'S HEAR FROM OUR ATTORNEY, CARLA. I WOULD IMAGINE THIS WOULD BE UNFINISHED BUSINESS AND THE CHANGES CAN BE MADE ON THE FLOOR AT THE NEXT COUNCIL MEETING. >> AS AN AF, I WOULD LOVE TO HAVE IT IN WRITING BEFORE HAND. >> DAVID?\R\N\R\N>> THANK YOU, CHAIR. ONE OPTION WE CAN CONSIDER IS HAVING BOTH THE ORIGINAL RESOLUTION POSTED UNDER UNFINISHED BUSINESS, AND THEN HAVE THE PROPOSED CD 1 VERSION INCORPORATING WHAT WAS DISCUSSED TODAY ALONG WITH THE TECHNICAL REVISIONS FOR THE BODY'S CONSIDERATION AND ALSO WILL HAVE THAT ON THE AGENDA, THANK YOU. >> FD 1? >> MEMBERS, DID YOU HEAR THAT? >> ANY OBJECTIONS TO THE SUGGESTION? >> NO OBJECTION, BUT CLARIFICATION. IT WILL BE ON THE AGENDA, CORRECT? >> YES.\R\N\R\N>> THE FD 1 CORRECT. >> >> COUNCIL CHAIR ALICE LEE: IT WILL BE TABLED TO THE NEXT COUNCIL MEETING AND PRESENTED BY STAFF AT THE NEXT COUNCIL MEETING. IF WE CAN GET ANYTHING AHEAD OF TIME, LET'S TRY TO DO THAT. YOU WILL GET IT AT LEAST AT POSTING. ANY OTHER QUESTIONS ON THIS MATTER? >> COUNCILMEMBER KEANI RAWLINS-FERNANDEZ: CHAIR? MAHALO.\R\N\R\NMEMBER KAMA ASKED ABOUT FUNDS. I THINK

\$36 MILLION. HOW MUCH HAS ALREADY BEEN COMMITTED ND ARE WE GOING TO GET A BUDGET AMENDMENT OR FOR ADDITIONAL FUNDS? I'M SORRY. THAT PART WASN'T SUPER CLEAR FOR ME BEFORE WE MOVE ON? >> COUNCIL CHAIR ALICE LEE: DEPUTY? >> THANK YOU, CHAIR.\R\N\R\NAND COUNCIL MEMBER. THERE ARE CURRENTLY NO AFFORDABLE HOUSING FUNDS FOR THIS PROJECT. THERE ARE NO ALLOCATIONS FOR THIS PROJECT OUT OF THE AFFORDABLE HOUSING FUND. >> OKAY, SO AT NO TIME IN THE PAST DID WE SUPPORT FUNDING FOR THIS PROJECT, NO FUNDING EVER, BUT MR. CARNEY CHELLY SAID THAT HE'S POSSIBLY GOING TO BE REQUESTING \$36 MILLION TO SUPPORT THIS? I'M SORRY. THAT'S NOT CLEAR.\R\N\R\N>> THANK YOU, CHAIR. AND THANK YOU, COUNCIL MEMBER RAWLINGS FERNANDEZ FOR THE QUESTION. THERE WAS \$6 MILLION APPROPRIATED IN FY24'S BUDGET FOR THIS PROJECT, AND IN FY24 AND MIDYEAR CYCLE, IF ADMINISTRATION REQUESTED FROM THE COUNCIL TO REMOVE THE FUNDING IN FY2024 FOR THE PROJECT AND WITH WOULD HE PUT THAT FUNDING INTO FY25 BUDGET PROPOSAL AT THE BUDGET SESSION. SO, THE BILL 35 FROM FY2024, WAS AT BUDGETED AMENDMENT THAT REMOVED THE FUNDING FOR THE PROJECT, AND THE COUNCIL PASSED THAT BILL, THE MAYOR PUT THE FUNDING BACK IN THE BUDGET FOR FY2025 IN APRIL OF LAST YEAR, AND THEN MY ECOLLECTION IS THAT FUNDING DIDN'T PASS AT THE COUNCIL LEVEL. SO THERE IS CURRENTLY NO FUNDING IN THE BUDGET FOR THE PROJECT. >> OKAY, THE LAST PART WAS ABOUT THE \$36 MILLION. HOW MUCH ARE YOU GOING TO BE REQUESTING FROM THE COUNTY FOR THIS PROJECT?\R\N\R\N>> THANK YOU, CHAIR. AND MEMBER RAWLINGS FERNANDEZ. WE ARE CURRENTLY NOT ASKING FOR ANY FUNDING FOR THE PROJECT. I WOULD LIKE TO REQUEST MR. CARNEY CHELLY FOR REQUEST THE FUNDING. >> I WOULD REQUEST THAT FROM SOMEBODY ELSE AND IT'S TIME TO CLOSE THIS ISSUE FOR THE MEETING. I DON'T WANT TO GET INTO THE CAUSE BECAUSE THE ISSUE IS THE TIMELINE. THE EXTENDING OF THE TIME. YOU ALREADY HEARD THEY ARE CONTEMPLATING CHANGES.\R\N\R\NSO THERE IS NO SENSE TALKING ABOUT MONEY AT THIS POINT OR ANY OTHER DETAILS. OKAY? MEMBER PALTIN? >> OKAY. CHAIR. >> >> COUNCILMEMBER TAMERA PALTIN: ONE QUESTION, YOU WOULDN'T BE APPLYING FOR DR FUNDS, RIGHT? BECAUSE LAHAINA REALLY NEEDS TO REBUILD.\R\N\R\N>> DID YOU HEAR THAT QUESTION? >> SO, MR. DOWLING, DID YOU HEAR THE QUESTION ABOUT ARE YOU PLANNING TO APPLY FOR DR FUNDS, CDBG DR FUNDS? DO YOU KNOW WHAT THAT IS? >> CAN COUNCIL MEMBER PALTIN, COUNCIL CHAIR LEE, YES, WE ARE BUT NOT FOR THIS PROJECT. WE ARE WORKING ON OTHER BURN AREAS IN LAHAINA THAT WE ARE APPLYING FOR DR FUNDS BUT NOT FOR THIS PROJECT. >> SHE MEANT FOR THIS PROJECT.
