BILL NO. <u>13, CD1</u> (2023)

A BILL FOR AN ORDINANCE AMENDING CHAPTER 12.40, MAUI COUNTY CODE, TO RENAME PUAMANA BEACH PARK IN LĀHAINĀ TO WAIAHIOKOLE BURIAL PRESERVE

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Chapter 12.40, Maui County Code, is amended by adding a new section to read as follows:

"12.40.310 Waiahiokole Burial Preserve. Waiahiokole Burial Preserve refers to the area formerly known as Puamana Beach Park, identified as tax map key (2) 4-6-033:001, and located on Honoapi'ilani Highway, Lāhainā, Hawai'i."

SECTION 2. New material is underscored. In printing this bill, the County Clerk need not include the underscoring.

SECTION 3. This Ordinance takes effect on approval.
