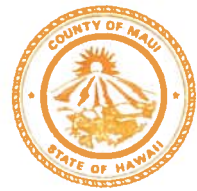

WHEREAS, by correspondence dated May 9, 2019, Mayor Michael P. 
WHEREAS, Section 13-2, Charter, requires the Mayor's nominee to be approved by the Council; and
