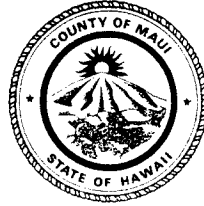

SUBJECT: FISCAL YEAR ("FY") 2018 BUDGET (BF-1)

On behalf of the Department of Environmental Management, I am transmitting the attached proposed bill for the purpose of repealing Section 14.34.070, Maui County Code relating to collection/transmission system project assessment fee.

According to the department, the County stopped collecting this fee in April 2015 and no longer foresees its continued need. As a result, the department is requesting that it be repealed from the Maui County Code. The corresponding fee pertaining to the Kihei Regional Wastewater Treatment System has been removed from Appendix B, Revenues – Fees, Rates, Assessments and Taxes of the FY 2018 Mayor's Proposed Budget that was transmitted on March 24, 2017.

BILL NO. _____ (2017)

A BILL FOR AN ORDINANCE REPEALING SECTION 14.34.070,
MAUI COUNTY CODE, RELATING TO COLLECTION/TRANSMISSION
SYSTEM PROJECT ASSESSMENT FEE

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Section 14.34.070, Maui County Code, is repealed.

“[14.34.070 Collection/transmission system project assessment fee. Applicants for building permits to construct developments shall be assessed a fee for the collection/transmission system upgrade. Such project assessment fee shall be determined by multiplying the component cost times the quotient of the project flow divided by the total number of gallons.]”

SECTION 2. Material to be repealed is bracketed. In printing this bill, the County Clerk need not include the brackets or the bracketed material.

SECTION 3. This ordinance shall take effect upon its approval.
