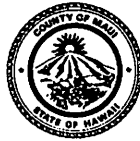

IN THE OFFICE OF COUNCIL SERVICES

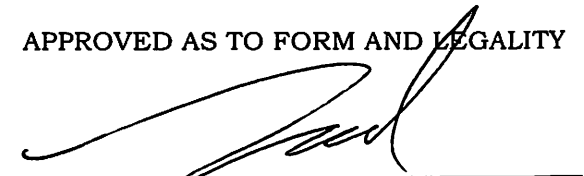
