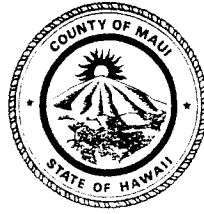


SUBJECT: SALARY FOR THE COUNTY AUDITOR
