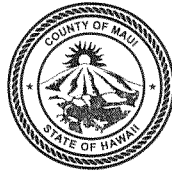

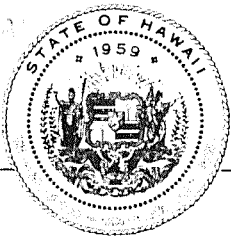

Dear Mr. Spence:

This is to inform you that we have received preliminary approval of our FY 2016-2017 Coastal Zone Management (CZM) grant-in-aid award. Upon award, we intend to commit to the County of Maui, via twelve (12)-month supplemental contract, a sum of \$373,276 for its participation in the FY 2016-2017 work program. The budget is as follows:

Personnel	\$367,168
Travel	\$2,563
Supplies	\$1,300
Equipment	\$1,595
Other	\$650
Total	\$373,276

In addition, the twelve (12)-month supplemental contract will require the County to provide at least \$329,878 worth of matching non-federal funds or services-in-kind for FY2016-2017, and time sheets must be prepared and filed with us for credit.

The execution of the twelve-month extension has proven to be more efficient than execution of a multi-year contract, beginning July 1, 2016. Additional twelve-month extensions for future fiscal years will be subject to the availability of funds.

We appreciate the County's observance of the contract requirements and would like to remind the County of the remaining FY2015-2016 contract services. These remaining services include the submittal of the final semi-annual status and performance report, the CZM Act performance measurement system related data, the final expenditure report, and documented non-federal services-in-kind contributions for FY 2015-2016.
