REFERRING TO THE PLANNING COMMISSIONS
A PROPOSED BILL TO AMEND CHAPTER 19.08,
MAUI COUNTY CODE, RELATING TO
NUISANCE IN THE RESIDENTIAL DISTRICTS

WHEREAS, the Council is considering a proposed bill for an ordinance to amend Chapter 19.08, Maui County Code, relating to nuisance in the Residential Districts; and

WHEREAS, Sections 8-8.4 and 8-8.6 of the Revised Charter of the County of Maui (1983), as amended, require the appropriate Planning Commissions to review proposed land use ordinances and amendments and provide findings and recommendations to the Council; now, therefore

BE IT RESOLVED by the Council of the County of Maui:

1. That it refers to the proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 19.08, MAUI COUNTY CODE, RELATING TO NUISANCE IN THE RESIDENTIAL DISTRICTS," a copy of which is attached as Exhibit "1," to the Lānaʻi Planning Commission, Maui Planning Commission, and Molokaʻi Planning Commission for appropriate action under Sections 8-8.4 and 8-8.6 of the Revised Charter of the County of Maui (1983);
2. That it respectfully requests the Planning Commissions transmit their findings as expeditiously as possible; and
3. That certified copies of this Resolution be transmitted to the Mayor, the Planning Director; the Lānaʻi Planning Commission, the Maui Planning Commission, and the Molokaʻi Planning Commission.

A BILL FOR AN ORDINANCE AMENDING CHAPTER 19.08, MAUI COUNTY CODE, RELATING TO NUISANCE IN THE RESIDENTIAL DISTRICTS

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Chapter 19.08, Maui County Code, is amended by adding a new section to be appropriately inserted and to read as follows:

“19.08.015 Nuisance. Nuisances are prohibited in the residential districts. “Nuisance” means a use, such as a hobby, that results in material annoyance, inconvenience, or discomfort to the neighborhood or the public, including, offensive noise, vibration, smoke, odors, dust, heat, glare, and garbage.”

SECTION 2. New material is underscored. In printing this bill, the County Clerk need not include the underscoring.

SECTION 3. This Ordinance takes effect on approval.
