The Maui Police Department has received your letter dated April 13, 2026, regarding Bill 49 (2026), AMENDING SECTION 10.48.040, MAUI COUNTY CODE, ON PARKING PROHIBITIONS FOR CERTAIN STREETS AND HIGHWAYS (WAI-23).

The Maui Police Department supports the amendment to Bill 49 to prohibit overnight parking on Lehuakona, Ala Makani, and Ohekani Streets in Kahului. Prohibiting overnight parking in these areas will effectively reduce the number of derelict, abandoned, and unsafe vehicles on these county roadways. If enacted, the Maui Police Department will enforce the County Code as applicable.
