Description: Woven tapestry of the Maui County seal by Alice Kagawa Parrott.

Condition: On-site examination of the artwork shows that it is stable. There is minimal color fading. Yarns, both warp and weft, still have tensile strength.

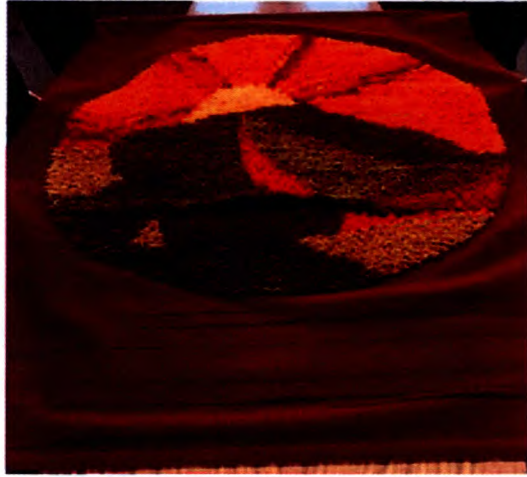
Final Treatment:

1. Before and after treatment photodocumentation with digital camera,
2. The piece was vacuumed front and back to remove dust.
3. Weft ends had worked their way to the front were woven back in to present a smoother appearance on the front.
4. There was a minor patch of a pale, crumbly accretion on the back and along a portion of one edge. This was removed mechanically with tweezers.
5. Weft pile threads that extended beyond the rest of the pile were woven back into the piece to an appropriate length.
6. Pile was fluffed and realigned so that original lacunae in the green sections were again visible.

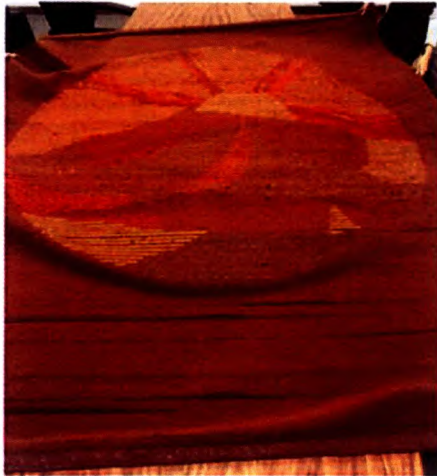

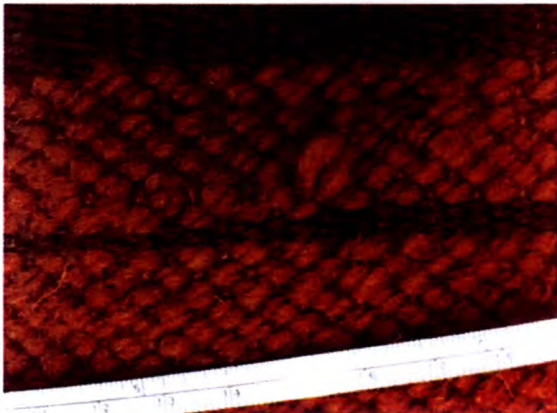
Before treatment



Overall front

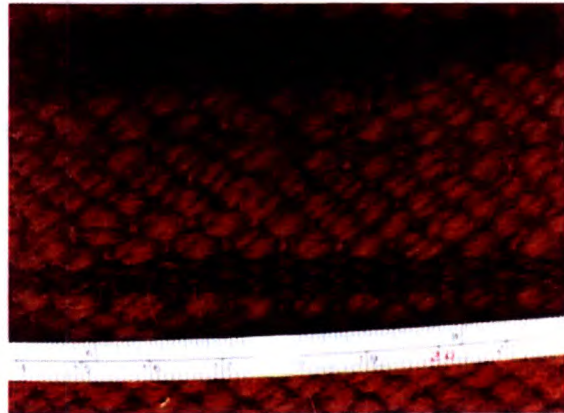
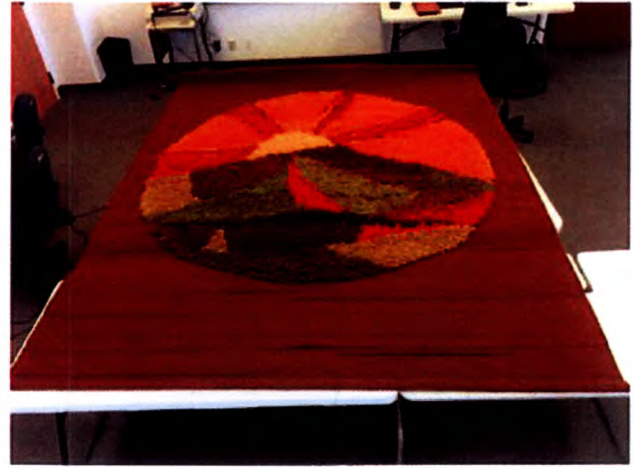


Overall back



Weft ends

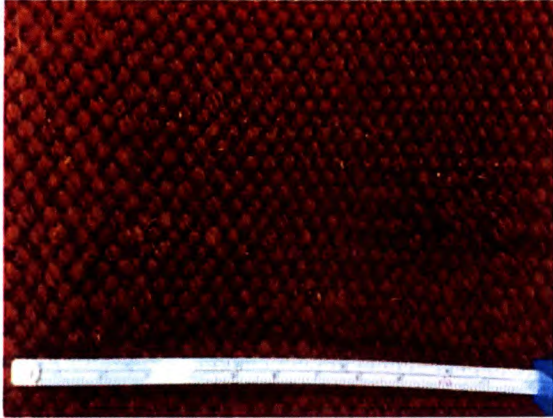

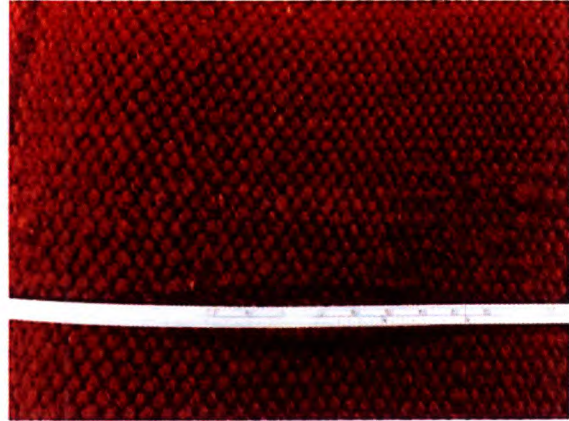

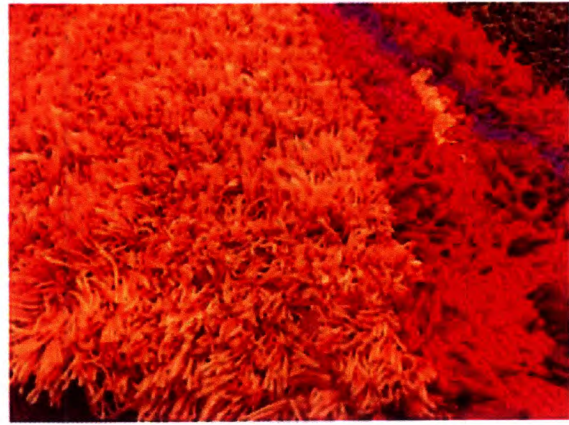
