#### Maui Wildfires Debris Removal Ordinance

Ordinance 5562 took effect on October 12, 2023.

Prohibits the issuance of building permits until removal of fire debris is completed through the government program or the alternative program.

ORDINANCE NO. 5562

BILL NO. 86, CD1, FD1 (2023)

A BILL FOR AN ORDINANCE RELATING TO MAUI WILDFIRES DEBRIS REMOVAL


BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Findings and declarations.

- A. Under section 46-1.5(13), Hawaii Revised Statutes, each county has "the power to enact ordinances deemed necessary to protect health, life, and property, and to preserve the order and security of the county and its inhabitants"; in addition, section 46-17, Hawaii Revised Statutes, says that "the council of any county may adopt and provide for the enforcement of ordinances regulating or prohibiting noise, smoke, dust, vibration, or odors which constitute a public nuisance."
- B. Beginning on and after August 8, 2023, several large wildfires have burned thousands of acres on Maui island in Lahaina, Kula, and Olinda, resulting in the death of an unconfirmed number of people and the destruction of over two thousand two hundred structures.
- C. Acting Governor Sylvia Luke's proclamation relating to wildfires declared a state of emergency in the counties of Maui and Hawai'i on August 8, 2023. Governor Josh Green, M.D. issued the seventh proclamation relating to wildfires on September 8, 2023. Among other actions, the governor declared in the seventh proclamation that disaster-generated debris on private property in

#### SAFETY ASSESSMENT PROGRAM

- DSA with support from Cal OES, conducted safety assessments of each structure within the disaster areas of Lahaina and Kula.
- Inspections began on 9/8 and were completed on 10/03
- Assessments completed:
  - Red: 1,799 (1,218 Red placards)
  - Yellow: 20
  - Green: 816
  - Grand total: 2,635

## EMERGENCY BUILDING PERMIT ORDINANCE

Ordinance 5629 took effect on March 11, 2024.

Updated existing building code provisions related to emergency alterations and repairs of structures in disaster affected areas.

BILL NO. 21, CD1 (2024)

A BILL FOR AN ORDINANCE AMENDING CHAPTER 16.25, MAUI COUNTY CODE, RELATING TO EMERGENCY BUILDING PERMITS


BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Section 16.25.105, Maui County Code, is amended by amending subsection 16.25.105.2.2 to read as follows:

"105.2.2 Emergency [alteration and repairs of one-and-two family dwellings and accessorv structures.] alterations, repairs, reconstruction, and new construction of structures in disaster affected areas. A. Applicability. Any existing [dwelling and its accessory structures that were legally erected and that have been damaged in] parcel affected by a disaster or civil defense emergency, recognized by the governor [pursuant to chapters 127 or 128.] under chapter 127A, Hawai'i Revised Statutes, [can be repaired pursuant to this section.] may construct, alter, repair, or reconstruct new and existing structures under this section. The provisions of this section [shall] remain in effect for a [two-year period] four-year period, beginning from the day the governor proclaims the state of disaster or emergency, and [shall] apply to those areas of the county covered by the governor's proclamation[.] and as declared by the mayor. This four-year period may be modified or extended by the mayor with an emergency proclamation. For the purposes of this section:

## **DSA Disaster Recovery Building Permit**

#### Overview

A Disaster Recovery Building Permit is for alterations, repairs, reconstruction, and new construction of structures on parcels affected by a disaster of civil defense emergency, recognized by the governor under Chapter 127A of the Hawaii Revised Statutes.

Separate disaster recovery permit applications have been prepared for:

- Single-Family Dwellings, Accessory Dwellings and Accessory Structures
- Multi-Family, Business, Commercial, Industrial and Other Non-Residential Structures

#### **How to Apply**

You must have a MAPPS <u>Customer Self Service</u> account in order to apply online. Navigate online to the <u>MAPPS CSS</u> page and login to your account. Apply for the applicable disaster recovery building permit. To avoid delays in processing your application, please follow these guidelines when applying:

## RECOVERY PERMITTING ONGOING EFFORTS

- Temporary Structures Permit requirements
- Record of Survey requirements
- Commercial Property Road Improvements

- Factory-Built Homes permit and inspection procedures
- SMA and Shoreline review process

## HOW ARE PERMITS BEING "EXPEDITED"?

- Consolidated application
  - Electrical, plumbing, grading, driveway, and building permits are consolidated into a single application and permit.
- Fast track applications
  - Disaster recovery permits are processed separately from non-emergency permits.
- Third-party permitting services
  - Permits won't be stuck in the existing review backlog

## HOW ARE PERMITS BEING "EXPEDITED"?

- Previously existing utility services
  - Verifying the adequacy of water and sewer service is already complete for the disaster area.
- Re-issuance of permits for recently built structures
  - Any structure built under a permit issued within five years prior to the date of the disaster.
- Maintaining existing building standards.
  - Avoids delays that would result from the development, adoption, staff training, MAPPS configurations, and implementation of new standards
