Pursuant to Section 3.44.015 H. of the Maui County Code, this letter shall serve as notice that the County of Maui has accepted the dedication of a Waterline Easement by the Department of Water Supply – Engineering Division. The parcel is identified by the subject Tax Map Key Number.

In addition, the Department of Water Supply has provided additional information pursuant to Section 3.44.015, F.2 of the Maui County Code.

Maui Lani Phase 6 Increment 4 Subdivision
Description of Easement U-9

A Waterline Easement in favor of the County of Maui over and across a portion of Lot 225-A (Unahe Street) of Maui Lani Phase 6 Increment 4 Subdivision, also affecting a portion of Grant 3343 to Claus Spreckels at Wailuku, Maui, Hawaii and being more particularly described as follows:

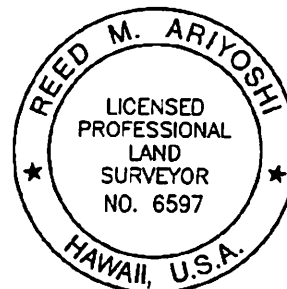
Beginning at a point at the most easterly corner of this easement, the azimuth and distance from the northeasterly corner of Lot 144-A and the northwesterly corner of Lot 149-A of Maui Lani Phase 6 Increment 4 Subdivision being: $109^{\circ} 17' 57.5''$ 21.53 feet, the coordinates of said point of beginning referred to Government Survey Triangulation Station "LUKE" being: 3,892.34 feet South and 2,426.85 feet East and running by azimuths measured clockwise from True South:

1. Thence along Lot 144-A of the Maui Lani Phase 6 Increment 4 Subdivision, being also along the remainder of Grant 3343 to Claus Spreckels on a curve to the left, with the point of curvature azimuth from the radial point being: $198^{\circ} 39' 58''$ and the point of tangency azimuth from the radial point being: $177^{\circ} 20'$, having a radius of 54.00 feet, the chord azimuth and distance being: $97^{\circ} 59' 59''$ 19.99 feet;
2. $87^{\circ} 20'$ 46.52 feet along Lots 144-A and 143-A of Maui Lani Phase 6 Increment 4 Subdivision, being also along the remainder of Grant 3343 to Claus Spreckels;

3. Thence along Lot 143-A of the Maui Lani Phase 6 Increment 4 Subdivision, being also along the remainder of Grant 3343 to Claus Spreckels on a curve to the right, with the point of curvature azimuth from the radial point being: $357^{\circ} 20'$ and the point of tangency azimuth from the radial point being: $28^{\circ} 00'$, having a radius of 80.00 feet, the chord azimuth and distance being: $102^{\circ} 40'$ 42.31 feet;
4. $118^{\circ} 00'$ 71.33 feet along Lots 143-A and 209-A of Maui Lani Phase 6 Increment 4 Subdivision, being also along the remainder of Grant 3343 to Claus Spreckels;
5. Thence along Lot 209-A of the Maui Lani Phase 6 Increment 4 Subdivision, being also along the remainder of Grant 3343 to Claus Spreckels on a curve to the left, with the point of curvature azimuth from the radial point being: $208^{\circ} 00'$ and the point of tangency azimuth from the radial point being: $196^{\circ} 41' 49''$, having a radius of 200.00 feet, the chord azimuth and distance being: $112^{\circ} 20' 54.5''$ 39.39 feet;

6. Thence along the remainder of Lot 225-A (Unahe Street) of the Maui Lani Phase 6 Increment 4 Subdivision, being also along the remainder of Grant 3343 to Claus Spreckels on a curve to the left, with the point of curvature azimuth from the radial point being: $16^{\circ} 41' 49''$ and the point of tangency azimuth from the radial point being: $15^{\circ} 10'$, having a radius of 1,026.00 feet, the chord azimuth and distance being: $285^{\circ} 55' 54.5''$ 27.40 feet;
7. $285^{\circ} 10'$ 128.17 feet along same;
8. Thence along same on a curve to the right, with the point of curvature azimuth from the radial point being: $195^{\circ} 10'$ and the point of tangency azimuth from the radial point being: $198^{\circ} 39' 58''$, having a radius of 974.00 feet, the chord azimuth and distance being: $286^{\circ} 54' 59''$ 59.48 feet, to the point of beginning and containing an Area of 2,350 Square Feet, more or less.
