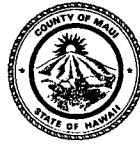

A BILL FOR AN ORDINANCE TO AMEND THE MAUI COUNTY CODE,  
CHAPTER 6.04.040, RELATING TO FEEDING FERAL ANIMALS

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Section 6.04.010, Maui County Code, is amended by adding  
a new definition to be appropriately inserted and to read as follows:

“Feral animal’ means any animal existing in a wild or  
untamed state or any animal having returned to an untamed state  
from domestication.”

SECTION 2: Chapter 6.04, Maui County Code, is amended by adding a  
new section to read as follows:

“6.04.041 Feeding of feral animals prohibited. No person  
may feed or deliberately introduce any food material, substance, or  
attractant directly to, or in the vicinity of, any feral animal.”

SECTION 3. New material is underscored. In printing this bill, the County  
Clerk need not include the underscoring.

SECTION 4. This ordinance takes effect upon its approval.
