BILL NO. _____ (2020)

A BILL FOR AN ORDINANCE AMENDING CHAPTER 1.16, MAUI COUNTY CODE, RELATING TO PUBLIC INSPECTION OF ADMINISTRATIVE RULES

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Section 1.16.060, Maui County Code, is amended to read as follows:

“1.16.060 - Amendments to rules. Each agency [shall] must incorporate amendments to its rules in accordance with the uniform format. A copy of amended rules [shall] must be filed with the county clerk within sixty days of the effective date of any amendments. Each agency must, at a minimum, review its administrative rules annually and no later than September 30 of each year to ensure they are maintained and updated.”

SECTION 2. Section 1.16.070, Maui County Code, is amended to read as follows:

“1.16.070 - Public inspection. Each agency [shall make] must: [its administrative rules available for public inspection and duplication during regular business hours.]

A. Publish in hard copy its administrative rules annually and no later than October 31 of each year.


B. Make its administrative rules, with all applicable updates, available for public inspection and duplication at each of its office locations during regular business hours.

C. Publish and maintain at all times its administrative rules on the county website.”

SECTION 3. Material to be repealed is bracketed. New material is underscored. In printing this bill, the County Clerk need not include the brackets, the bracketed material, or the underscoring.

SECTION 4. This ordinance shall take effect upon its approval.
