A BILL FOR AN ORDINANCE TO AMEND THE LANAI COMMUNITY PLAN

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

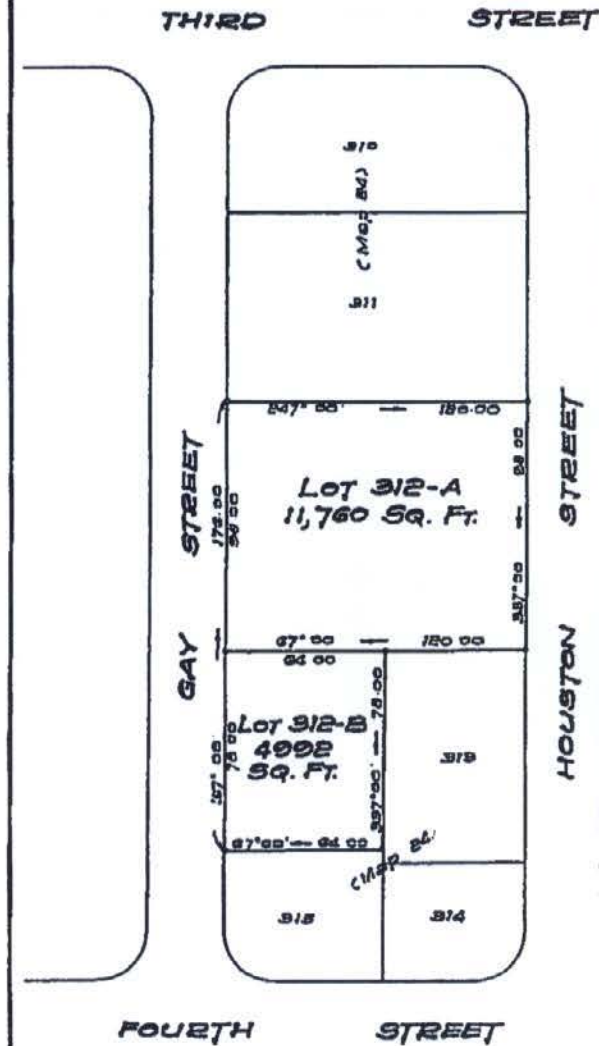

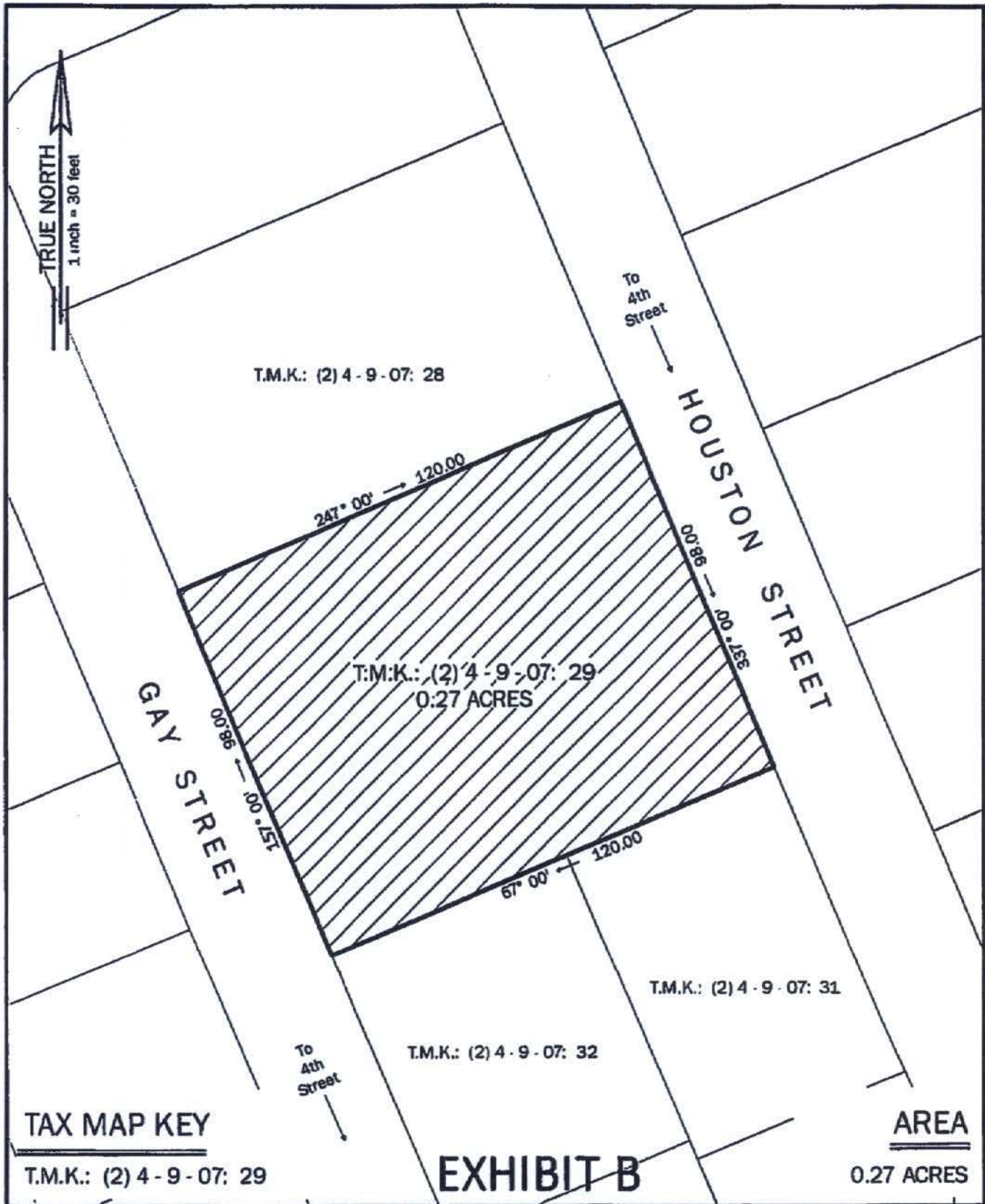

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

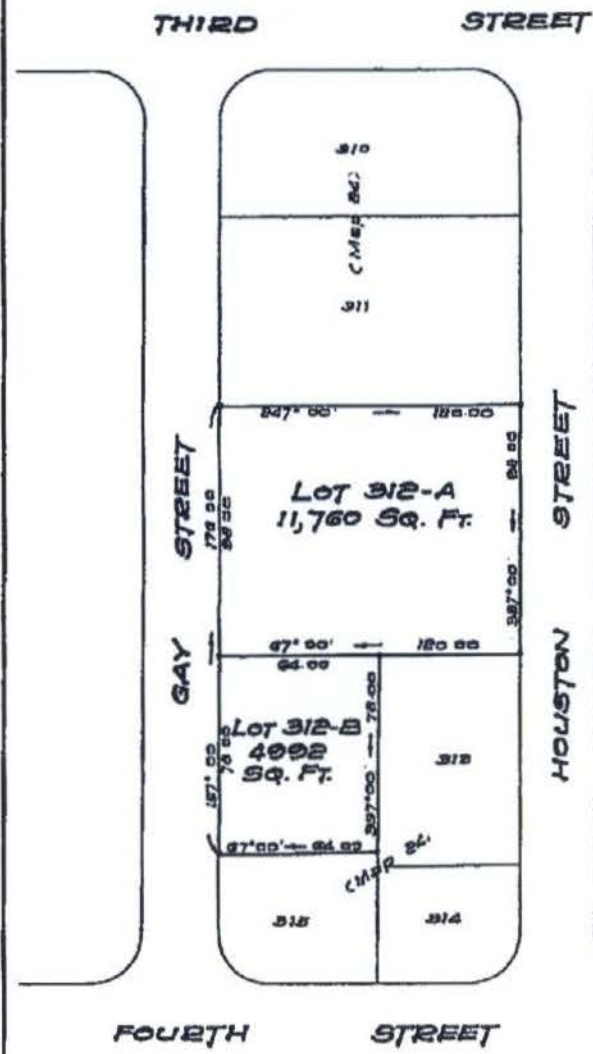

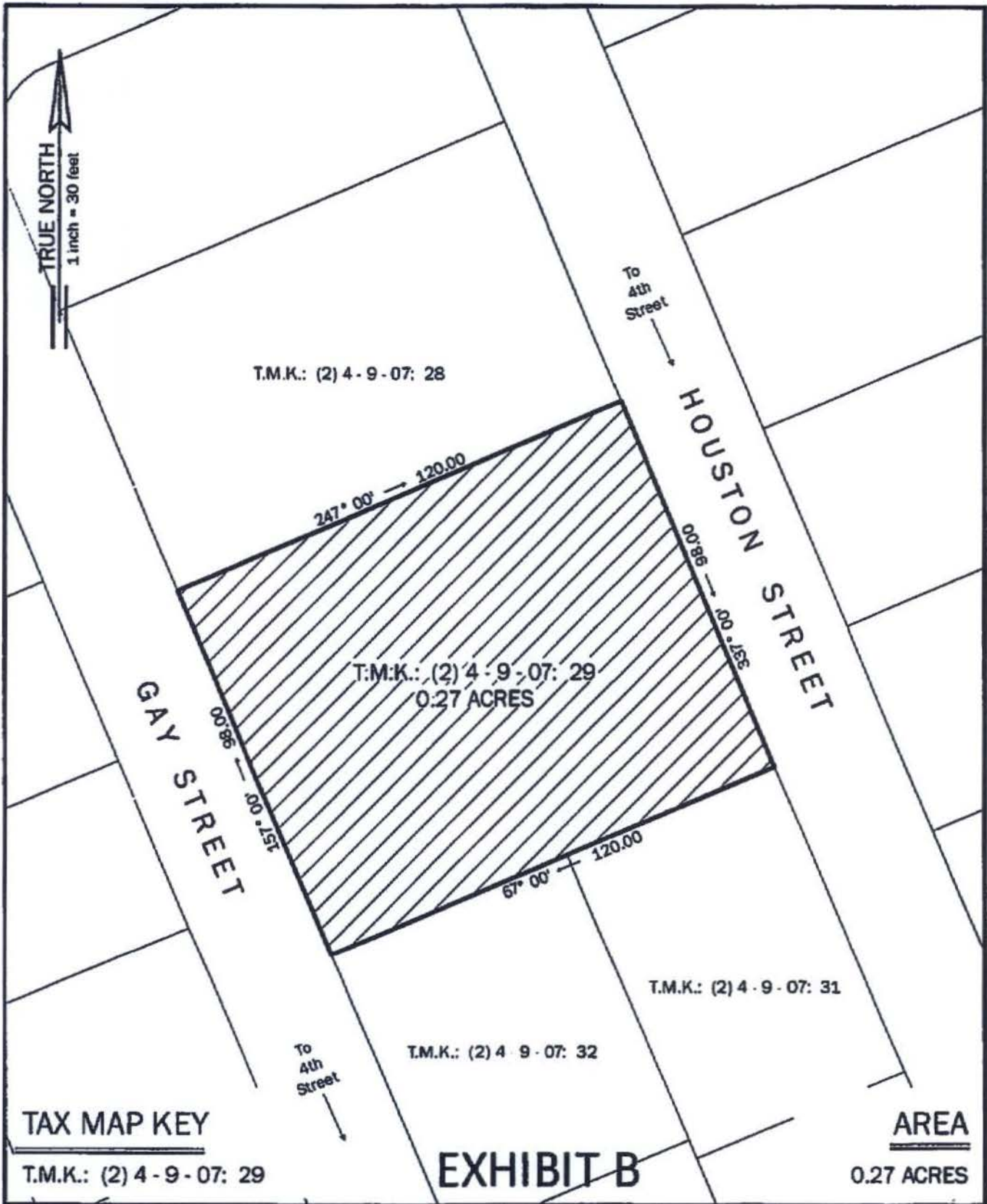

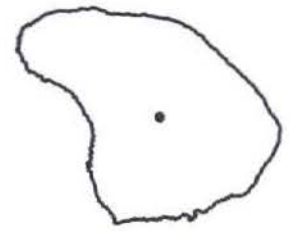


LAND ZONING MAP NO. L-2622

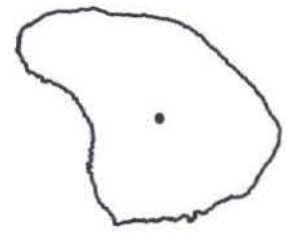
