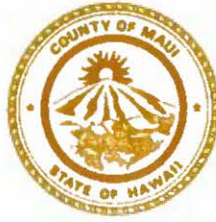

SUBJECT: RESOLUTION 24-155, AUTHORIZING THE COUNCIL CHAIR TO ISSUE A REQUEST FOR PROPOSALS FOR A FEASIBILITY STUDY OF A COUNTY DEPARTMENT OF GRANTS MANAGEMENT (ESCS-6)

Mahalo for the opportunity to respond to your questions. The Department of Planning's (Department) answers are below.

1. *In the Fiscal Year ("FY") 2025 Council Adopted Budget, Appendix A, Part I, attached, you project your Department will receive two grants. Do you anticipate applying for more grants in FY 2025 than you are projected to receive? Please explain.*

The Department does not anticipate applying for additional grants in FY 2025.
