REQUESTING RELEASE OF GENERAL OBLIGATION BOND FUNDS FOR COUNTY OF MAUI PROJECT CBS-7898 KULA AGRICULTURAL PARK PHASE 1 EXPANSION – UPCOUNTRY MAUI AG PARK; AUTHORIZED BY ACT 164, SLH 203, ITEM NO. SUB401

The County of Maui respectfully requests the release of the \$10,160,000 appropriated for the Upcountry Maui Agricultural Park ("UMAP") from Act 164, SLH 2023, Item No. SUB401.

The land acquisition for the new Upcountry Maui Agricultural Park was completed on December 31, 2018 with \$5,000,000 of State Funds and \$1,000,000 of County matching funds. We are now requesting \$10,000,000 of State Funds to match County contributed funds of \$10,000,000.

These funds will be used for the design, construction, ground and site improvements, equipment, and all project related costs, for the Kula Agricultural Park Phase 1 expansion.

Project specifics are as follows:

- 1. Environmental assessment, design and construction of the UMAP and water system consisting of a 2.4 million-gallon reservoir and distribution line.
- 2. Booster pump station relocation for the delivery of water to the Kula Agricultural Park and future delivery to UMAP.
