WHEREAS, Section 13-2, Revised Charter of the County of Maui (1983), as amended, and Chapter 2.41, Maui County Code, outline commission nomination procedures for the Mayor and the Council; and

WHEREAS, the Mayor did not submit a nomination to the Council by the deadline of September 10, 2016; and

WHEREAS, pursuant to Section 2.41.050, Maui County Code, in the event the Mayor fails to submit the name of a nominee within the time provided by law, the Council has sixty days from the expiration of the time so provided to nominate and approve an individual to fill the vacancy; and

WHEREAS, the Council is currently within its sixty-day period, which will expire on April 18, 2017, to nominate and approve the appointment of an individual to fill the vacancy; and

WHEREAS, Sharron Courter has indicated a desire to be appointed to the Cost of Government Commission for a term expiring March 31, 2018, and has submitted a completed application form with the information required by Section 2.41.020, Maui County Code; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That it hereby nominates and approves the appointment of Sharron Courter as a member to the Cost of Government Commission, for a term expiring March 31, 2018; and
