A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2024 BUDGET FOR THE COUNTY OF MAUI, APPENDIX C, CAPITAL IMPROVEMENT PROJECTS, OFFICE OF THE COUNTY CLERK, WAILUKU-KAHULUI COMMUNITY PLAN AREA

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 5528, Bill No. 22, CD1, FD2 (2023), as amended, "Fiscal Year 2024 Budget", Appendix C – Capital Improvement Projects, Office of the County Clerk, Wailuku-Kahului Community Plan Area is amended to modify the project description for CBS No. CBS-7893, to read as follows:

	[To best assist the voters of the County of Maui, and to provide sufficient office space, renovations] <u>Renovations</u> are necessary to the Office of the County Clerk, Kalana O Maui Building, 200 S. High Street, Wailuku[. Renovations include relocating the public access doorway, reconfiguring the current entry way and service windows to enable staff usage of those areas, installing voter service windows (similar to that of the Department of Water Supply) directly accessible by the public without requiring use of doorway access, and painting the offices and conference room. Funds are solely for planning and design.] <u>to replace worn and damaged flooring in staff areas, modify electrical and plumbing, and reconfigure workspaces.</u>


