## NOMINATING AND APPROVING THE APPOINTMENT OF EMMETT RODRIGUES TO THE POLICE COMMISSION

WHEREAS, a vacancy on the Police Commission for a term expiring on March 31, 2023, was created when Roger Dixon resigned effective September 28, 2020; and

WHEREAS, in accordance with Section 13-2(17), Revised Charter of the County of Maui (1983), as amended, the Mayor's thirty-day period to nominate an individual to fill that vacancy expired on October 28, 2020; and

WHEREAS, the Council is currently within its sixty-day period, which will expire on December 27, 2020, to nominate and approve the appointment of an individual to fill the vacancy; and

WHEREAS, Emmett Rodrigues has indicated a desire to serve on the Police Commission and has submitted a completed application form with the information required by Section 2.41.020, Maui County Code; now, therefore,
