Chair and Members:

Your Economic Development and Budget Committee, having met on February 14, 2019, makes reference to County Communication 19-16, from the Budget Director, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING APPENDIX A OF THE FISCAL YEAR 2019 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO PART II, SPECIAL PURPOSE REVENUES – SCHEDULE OF REVOLVING/SPECIAL FUNDS FOR FISCAL YEAR 2019, PLAN REVIEW, PROCESSING, AND INSPECTION REVOLVING FUND (FIRE)."

The purpose of the proposed bill is to amend Appendix A, Part II, Special Purpose Revenues – Schedule of Revolving/Special Funds for the Fiscal Year 2019 Budget, by transferring \$9,648 in appropriations under the Plan Review, Processing, and Inspection Revolving Fund (Fire) for operations or services to an appropriation for equipment. The funding would be used to purchase a fire extinguisher trainer and to replace malfunctioning equipment for the Keiki ID Program.

A Captain, Fire Prevention Bureau, Department of Fire and Public Safety, said the fire extinguisher trainer is used to train members of the community to properly use fire extinguishers. He explained the trainer is similar to a barbecue grill and creates a fire source upon which the chemicals from fire extinguishers can be applied to practice extinguishing fires. The Captain said the trainer the Department currently uses relies on fuel and is not working. He said the trainer had been used to train about 700 people per year. The Department would like to purchase an electronic trainer.

He also said the Keiki ID Program provides children with an identification card and allows the Department an opportunity to engage with the community and share fire prevention messages. The equipment being used is the original equipment used for more than 15 years and needs to be replaced.

Your Committee voted 8-1 to recommend passage of the proposed bill on first reading and filing of the communication. Committee Chair Rawlins-Fernandez, Vice-Chair King, and members Kama, Lee, Molina, Paltin, Sinenci, and Sugimura voted "aye." Committee member Hokama voted "no."

Your Committee is in receipt of a revised proposed bill, approved as to form and legality by the Department of the Corporation Counsel, updating the year of the bill.

Your Economic Development and Budget Committee RECOMMENDS the following:

OF THE FISCAL YEAR 2019 BUDGET FOR THE COUNTY OF MAUI
AS IT PERTAINS TO PART II, SPECIAL PURPOSE REVENUES SCHEDULE OF REVOLVING/SPECIAL FUNDS FOR FISCAL YEAR 2019,

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 4861 Bill No. 57 (2018), as amended, "Fiscal Year 2019 Budget", Appendix A, Part II, Special Purpose Revenues – Schedule of Revolving/Special Funds for Fiscal Year 2019, is hereby amended as it pertains to the Plan Review, Processing, and Inspection Revolving Fund (Fire), by adjusting the appropriations for operations or services and equipment, to read as follows:
