RELATING TO THE APPOINTMENT OF SCOTT CRAWFORD TO THE

WHEREAS, by correspondence dated September 1, 2021, Mayor Michael P. Victorino notified the Council he nominated Scott Crawford to the Hana Advisory Committee for the County of Maui for a term expiring on March 31, 2022, to fill a vacancy replacing David Kaina, pursuant to Section 2.40.130, Maui County Code and 13-2, Revised Charter of the County of Maui (1983), as amended (“Charter”); and

WHEREAS, Charter Section 13-2, requires the Mayor’s nominee to be approved by the Council; and

WHEREAS, Charter Section 13-2(17), requires the Council to approve or disapprove the nomination within sixty days after the Mayor submits the name of the nominee to the Council because of the death, resignation, or removal of a member; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That it approves the appointment of Scott Crawford to serve on the Hana Advisory Committee for the County of Maui for a term expiring March 31, 2022;
2. That the Council expresses its gratitude and appreciation to Scott Crawford for his willingness to be considered for public service and actively participate in County government; and
3. That certified copies of this Resolution be transmitted to the Mayor, the Managing Director, and the Corporation Counsel.
