AUTHORIZING THE ACCEPTANCE OF THE KAPALUA RESORT  
ASSOCIATION'S DONATION OF LABOR FOR IMPROVING D.T. FLEMING  
BEACH PARK, UNDER CHAPTER 3.56, MAUI COUNTY CODE

WHEREAS, the Kapalua Resort Association wishes to donate labor for the removal of 15 coconut tree stumps, and the trimming of approximately five iron wood trees at D.T. Fleming Beach Park to the Maui County Department of Parks and Recreation, as reflected in the letter dated April 18, 2025, attached as Exhibit "1"; and

WHEREAS, the estimated value of the labor is \$12,670.15; and


WHEREAS, Section 3.56.030, Maui County Code, authorizes the Council to accept gifts and donations by resolution on behalf of the County; now therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That it hereby expresses its appreciation to Kapalua Resort Association and accepts the donation of labor in the equivalence of \$12,670.15 on behalf of the County of Maui, under Chapter 3.56, Maui County Code;
2. That it authorizes the Mayor to execute all necessary documents in connection with the acceptance of the donation; and

3. That certified copies of this Resolution be transmitted to the Mayor, Director of Finance, Director of Parks and Recreation, and Frank Violi, Jr., Director of Kapalua Resort Association.

RE: DT Fleming Beach Park Donation from Kapalua Resort Association

Aloha,

Kapalua Resort Association's Board of Directors has approved it's 2025 Budget which includes a line item for improving DT Fleming Beach Park.

Recently the County cut down 15 coconut palms that had died and were destined to fall somewhere in the park. While the entire scope of work for future projects has not been completed, collaboration with the Parks & Recreation Department is welcome.

At this time KRA has identified multiple potential safety hazards/dead wood regarding the ironwoods trees above and around the picnic tables and the tripping hazard presented by the coconut palm stumps.

KRA is requesting approval from the Parks and Recreation and if necessary, County Council to allow KRA to spend the money necessary to reduce the risk. KRA and/or it's arborist is willing to provide a Certificate of Insurance and with the proposed project's approval will need a right of entry before work would commence.

If additional requirements are necessary please contact KRA with details and we will follow up. After receiving multiple proposals for the stump grinding and tree trimming 'Ehu Kai was chosen as the service provider and his proposal is also attached for reference.
