1. Please provide an estimated timeframe for bills to be issued to West Maui and Upcountry water consumers impacted by the August 2023 fires.

**RESPONSE:** 

#### West Maui:

- a) Customers who were not impacted by the WildFire bills were sent on Wednesday, November 15<sup>th</sup> (consumption and monthly charge for Sept 2023 to Nov 2023)
- b) Customers who were or still in the Unsafe Water Advisory (UWA) bills will be sent upon Council's approval of the proposed emergency rate (no consumption charge during UWA).

c) Customers impacted by the WF – no bill will be sent until the houses are rebuild or when customer requests for temporary meter (bill for monthly charge and for irrigation use).

### **Upcountry (Upper Kula):**

- a) The department has been sending the bills to customers who were under the Unsafe Water Advisory (UWA). Adjustment to customer's account will be issued upon Council's approval of the proposed emergency rate.
- b) Meter has recently been installed to those 19 customers impacted by the Wildfire, bill is scheduled to be mailed in December 2023.
- 2. Will payment plan options be available? Please provide details.

#### **RESPONSE:**

Yes. Payment arrangement would be based on the amount owed (outstanding balance), customer's current situation/circumstances, and term would be based on how much the customer can afford.
