Chair and Members:

Your Policy, Economic Development, and Agriculture Committee, having met on March 6, 2017, makes reference to County Communication 17-7, from Council Chair Mike White, relating to nominations to boards, committees, and commissions.

By correspondence dated and received February 23, 2017, the Mayor transmitted a proposed resolution entitled "RELATING TO THE APPOINTMENT OF LUANA KAWA'A TO THE MAUI COUNTY CULTURAL RESOURCES COMMISSION," along with a completed application for the nominee.

The purpose of the proposed resolution is to approve or disapprove the Mayor's nomination of Luana Kawa'a to the Maui County Cultural Resources Commission, for a term expiring on March 31, 2018, to fill a vacancy due to the resignation of Owana Salazar.

Your Committee notes general appointment procedures for boards and commissions are outlined in Section 13-2, Revised Charter of the County of Maui (1983), as amended, and Chapter 2.41, Maui County Code. Specific provisions for the Maui County Cultural Resources Commission are contained in Sections 2.40.110 and 2.88.030, Maui County Code.

Your Committee further notes the Council has until April 24, 2017, to approve or disapprove the Mayor's nominee, or the nominee will be deemed appointed.

Your Committee did not request to interview the nominee.

WHEREAS, by correspondence dated February 23, 2017, Mayor Alan M. Arakawa notified the Council he nominated Luana Kawa'a to the Maui County Cultural Resources Commission for a term expiring on March 31, 2018, to fill a vacancy replacing Owana Salazar, pursuant to Sections 2.40.110 and 2.88.030, Maui County Code, and Section 13-2, Revised Charter of the County of Maui (1983), as amended, ("Charter"); and
