

SUBJECT: FISCAL YEAR 2017 SOLID WASTE FUND ESTIMATED REVENUE SHORTAGE (BF-47)

The County is in receipt of the above Budget and Finance (BF) Committee requested information dated November 9, 2017. Your request and the corresponding answer is provided below by the Department of Environmental Management (DEM).

1) Provide the actual amount of the shortfall of Solid Waste revenue for Fiscal Year 2017. Indicate the revenue category resulting in the shortfall.

The fiscal year end amount of Solid Waste revenue for Fiscal Year 2017 ended up being short by only \$48,735, (or one quarter of one percent / 0.25%) of the original estimated revenue, which is well within normal estimates year to year. The shortfall occurred in Refuse Collection revenue, which is always subject to many variables and is an estimate only each year. The shortfall was offset by an overage in the actual Landfill revenue, Interest revenue, and savings related to administrative overhead. Please see the itemization below for Fiscal Year 2017.

The Mayor's letter to Council dated April 19, 2017 was routine correspondence to meet the requirements of the Maui County Charter Section 9-10.1.

2) Provide a year-to-date comparison of the projected revenue and the actual revenue for the various waste material revenue categories for Fiscal Years 2015 through 2017.
