- 3. What training, if any, was provided by your Department between 10:00 p.m. on August 7, 2023, and 10:00 p.m. on August 21, 2023?
- 4. When, if at all, was the first wildfire in Lāhainā on August 8, 2023, deemed 100% contained? What resources did your Department send to respond to this initial fire?

- 5. Did your Department request assistance from any other agencies or entities, such as the Department of Public Works, State agencies, or companies with private heavy machinery operators? If so, what assistance was requested and when?
- 6. How many communication channels did your Department use between 10:00 p.m. on August 7, 2023, and 10:00 p.m. on August 21, 2023? What time was each channel started? Who, if anyone, was monitoring those channels?
- 7. What incident commands were activated between 10:00 p.m. on August 7, 2023, and 10:00 p.m. on August 21, 2023? What resources were assigned to each incident command?
