

### **MAUI ISLAND WATER USE AND DEVELOPMENT PLAN (WIT-25)**

**Description:** The Committee is in receipt of the following:

1. County Communication 19-162, from the Director of Water Supply, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE ADOPTING AN UPDATE TO THE WATER USE AND DEVELOPMENT PLAN FOR THE ISLAND OF MAUI." Attached to the proposed bill is a document entitled "Maui Island Water Use and Development Plan DRAFT, MARCH 2019." The purpose of the proposed bill is to adopt the attached document as an update to the Maui County Water Use and Development Plan, in accordance with Section 14.02.040, Maui County Code.
2. Correspondence dated June 24, 2020, received June 30, 2020, from the Director of Water Supply, transmitting an addendum to the Water Use and Development plan for the Island of Maui. The purpose of the addendum is to provide necessary updates on relevant developments or decisions that have occurred since the plan was submitted on August 10, 2018.
