A BILL FOR AN ORDINANCE AMENDING SECTION 3.25.030,
MAUI COUNTY CODE, RELATING TO HIGHWAY BEAUTIFICATION FEE

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Section 3.25.030, Maui County Code, is amended to read as follows:

“3.25.030 Highway beautification fee-revolving fund. A. The director of finance, in accordance with section 286-51(b), Hawaii Revised Statutes, as amended, shall annually collect an additional fee for each certificate of registration.

The amount of the fee to be collected shall be set forth in the annual budget.

B. The moneys so assessed and collected shall be placed in a revolving fund entitled, “the highway beautification [and disposal of abandoned or derelict vehicles], abandoned vehicle, and tourism-related traffic congestion revolving fund,” to be used and administered by the County for the purpose of beautification and other related activities, including, but not limited to, animal management program carcass removal and highway beautification, concerning highways under the ownership, control, and jurisdiction of the County[, and]; to defray the additional cost in the disposition and other related activities of abandoned or derelict vehicles as prescribed in chapter 290, Hawaii Revised Statutes[.]; and to mitigate and address the impacts of tourism-related traffic congestion.

C. Expenditures from the fund shall be through appropriations set forth in Appendix A.II. of the annual budget ordinance.”

SECTION 2. Material to be repealed is bracketed. New material is underscored. In printing this bill, the County Clerk need not include the brackets, the bracketed material, or the underscoring.

SECTION 3. This ordinance takes effect on January 1, 2023.
