WHEREAS, the 185 pairs of footwear are donated to provide protective footwear for all ocean safety officers employed in the lifeguard division; and


WHEREAS, the Department may allow photos of ocean safety officers wearing the donated footwear on a voluntary basis and on non-work time; and

OluKai is honored to forward this formal proposal to donate footwear with the County of Maui's Ocean Safety Bureau.

Our goal is to donate product to the Maui County Ocean Safety Officers by providing them with high quality footwear to be worn while on duty. This is a relationship that we believe will be mutually beneficial.
