The Mayor's Office Budget will decrease by approximately 13% overall in the upcoming fiscal year. This reduction is primarily due to the removal of the Community Development Block Grant-DR (CDBG-DR), as well as the transfer of several grants to departments better suited to administer them. These changes are intended to improve efficiency, streamline operations, and ensure that programs are managed by the most appropriate agencies.
