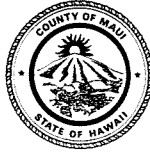



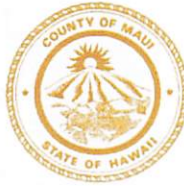

On behalf of the Department of Finance, I am transmitting the following:

1. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2023 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO ESTIMATED REVENUES; DEPARTMENT OF FINANCE, TOTAL OPERATING APPROPRIATIONS; TOTAL APPROPRIATIONS (OPERATING AND CAPITAL IMPROVEMENT PROJECTS)."

The purpose of the proposed bill is to amend the FY 2023 Budget by increasing the estimated revenues for Carryover/Savings from the General Fund by \$7,000,000 and appropriating the funds to the Department of Finance, Countywide Costs, Temporary Hazard Pay related to COVID-19 Grievances.

2. A Certification of Additional Revenues for Carryover/Savings from the General Fund for \$7,000,000.

The proposed amendment would increase the appropriation for Temporary Hazard Pay related to COVID-19 Grievances from \$20,000,000 to \$27,000,000. To date, expenditures for the United Public Workers employees were made from the fund. The additional funds would provide for a portion of the expenditures required under the arbitration decision involving temporary hazard pay for Hawaii Government Employees Association members.

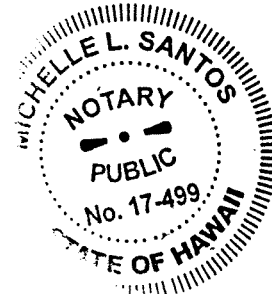
