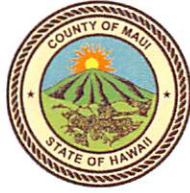

(Waterline Easement)**

A Waterline Easement 1-B in favor of the County of Maui, over and across a portion of Lot 3-A-1-D-1 of Kehalani Mauka (Large-Lot) Subdivision No. 3-C, also affecting a portion of Royal Patent 1925, 1928, 1958, Land Commission Award 387, Part 5, Section 1 to A.B.C.F.M. at Wailuku, Maui, Hawaii and being more particularly described as follows:

Beginning at a point at the northwesterly corner of this easement, the azimuth and distance from the southwesterly corner of Lot 3-A-1-E-2-A and the northwesterly corner of Lot 3-A-1-D-1 of Kehalani Mauka (Large-Lot) Subdivision No. 3-C being: 306° 16' 73.51 feet, the coordinates of said point of beginning referred to Government Survey Triangulation Station "LUKE" being: 15.24 feet South and 6,362.35 feet West and running by azimuths measured clockwise from True South:

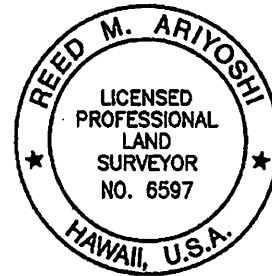
