RELATING TO THE APPOINTMENT OF RICKY  
SANCHES TO THE MAUI COUNTY  
COMMISSION ON PERSONS WITH  
DISABILITIES

WHEREAS, there is a forthcoming vacancy on the Maui County Commission on Persons with Disabilities due to the upcoming expiration of the term of a member on March 31, 2017; and

WHEREAS, Section 13-2(16), Revised Charter of the County of Maui (1983), as amended, provides that the Mayor may submit names to fill vacancies on boards and commissions not more than seventy, nor less than sixty days before the vacancy is to occur; and

WHEREAS, the Mayor did not submit the name of a nominee to fill a forthcoming vacancy on the Maui County Commission on Persons with Disabilities within the time provided by Section 13-2(16) of the Revised Charter of the County of Maui (1983), as amended; and

WHEREAS, pursuant to Section 2.41.050, Maui County Code, in the event the Mayor fails to submit the name of a nominee within the time provided by law, the Council has sixty days from the expiration of the time so provided to nominate and approve an individual to fill the forthcoming vacancy; and

WHEREAS, Ricky Sanches has indicated a desire to be appointed to the Maui County Commission on Persons with Disabilities for a term commencing April 1, 2017, and expiring March 31, 2022, and has submitted a completed application form with the information required by Section 2.41.020, Maui County Code; now, therefore,


BE IT RESOLVED by the Council of the County of Maui:

1. That it hereby nominates and approves the appointment of Ricky Sanches as a member to the Maui County Commission on Persons with Disabilities, for a term commencing April 1, 2017, and expiring March 31, 2022; and
