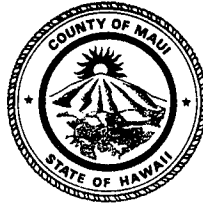


WHEREAS, Charter Section 13-2, requires the Mayor's nominee to be approved by the Council; and

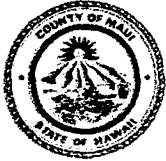
BE IT RESOLVED by the Council of the County of Maui:
