#### KUIKAHI VILLAGE **UPDATES** ON THE WORKFORCE HOUSING PROJECT (HLU-3(8))

**Description:** Under Rule 7(B) of the Rules of the Council, the Committee intends to receive a presentation and discuss matters relating to the Kuikahi Village Workforce Housing Project ("Project") that received approval under Chapter 2.97, Maui County Code, by Resolution 22-193, CD1, FD1. The Project's developer, Kuikahi Properties, LLC, is considering requesting that the Council authorize converting the Project from for-sale units under Chapter 2.97, Maui County Code, to 100 percent rental units under Chapter 201H, Hawai'i Revised Statutes. The project site is a 14.97-acre parcel located in Wailuku, Maui, Hawai'i, identified for real property tax purposes as tax map key (2) 3-5-002:003 (por.).

<u>Status:</u> The Committee may receive a presentation from representatives of the Kuikahi Village Workforce Housing Project, including discussion changing the Project to one requiring approval under Chapter 201H, Hawai'i Revised Statutes. The Committee may also discuss other related matters. No legislative action will be taken.

**<u>Description:</u>** The Committee is in receipt of the following:

- 1. Bill 70 (2023), entitled "A BILL FOR AN ORDINANCE AMENDING ORDINANCE NO. 3545, BILL NO. 29 (2008) TO TRANSFER A CONDITIONAL PERMIT TO JOSHUA RAMU TREMBLAY FOR THE OLD WAILUKU INN TRANSIENT VACATION RENTAL SITUATED AT 2199 KAHO'OKELE STREET, WAILUKU, HAWAII."
