OFFICIAL TESTIMONY LOCATION

Members of the public may view the meeting and provide testimony in person at the Council Chamber, Kalana O Maui Building, 8th Floor, 200 South High Street, Wailuku, Hawai'i.

If audiovisual connection with the Council Chamber is lost, the Council will be in recess for up to 30 minutes to restore connectivity. If connectivity cannot be restored within 30 minutes, the meeting will automatically reconvene the following Wednesday at 9:00 a.m., using the same official location for in-person testimony and viewing, unless the Council announces a different date, time, and location.

TESTIMONY PROCEDURES

Individuals may provide oral testimony by phone or video conference. To join the meeting by phone, call 1-408-317-9253 and input meeting code 295235670. To join by video conference, use the following link: https://maui.bluejeans.com/295235670.

Oral testimony on any agenda item will be accepted at the beginning of the meeting and prior to Council's deliberation on each section of the agenda. Testimony must pertain to items on the agenda. Each testifier shall be allowed to speak for up to three minutes on each item. The time limits for testimony may be modified, if the modification is initiated by the presiding officer and approved by a majority of the Council; provided that a modification would apply equally to all testifiers and all items. No further oral testimony by the testifier on the item shall be permitted. An individual's request to testify may be deemed withdrawn if the individual does not answer when called to testify. If the connection between any testifier and the video conference is lost, the meeting will still continue.

If a testifier wishes to testify anonymously, please indicate that request in the Bluejeans chat or with staff at the sign-up desk outside the Council Chamber. Anonymous testifiers will be assigned a number.

DECORUM

Any person who behaves in a manner that disrupts, disturbs, or impedes the orderly conduct of the Council meeting may, at the discretion of the presiding officer or a majority of present Councilmembers, be removed from the Council Chamber or, if participating remotely, muted or dropped from the meeting. Disruptive behavior includes, but is not limited to: heckling, shouting, use of profanity, and threatening remarks made to any member of the Council, staff, or general public.

The purpose of this bill is to amend Ordinance No. 4405 to grant a time extension/amendment to the conditional permit in order to continue to conduct limited special events, historical and botanical tours, photo shoots, workshops, retreats, wellness and exercise classes, and to allow a bridal lounge and event preparation space in an existing agricultural building.

Bill 83 (2023) "A BILL FOR AN ORDINANCE AMENDING SECTION 19.47.070, MAUI COUNTY CODE, RELATING TO WETLANDS OVERLAY MAPPING"

The purpose of this bill is to amend the Department's timeline for preparing the wetlands overlay map.

Bill 84 (2023) "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2024 BUDGET FOR THE COUNTY OF MAUI, OFFICE OF THE MAYOR, ECONOMIC DEVELOPMENT PROGRAM, GRANTS AND DISBURSEMENTS FOR VISITORS INDUSTRY, TOURISM MANAGEMENT GRANT FUND"

The purpose of this bill is to amend the Fiscal Year 2024 Budget to delete conditional language stating the Tourism Management Grant Fund may not be used for marketing and promotion but must be used for tourism management or education efforts.

Bill 28, CD1, "A BILL FOR AN ORDINANCE AMENDING ORDINANCE NO. 4998 (2019)

FD1 (2023) RELATING TO THE CHANGE IN ZONING (CONDITIONAL ZONING) TO WAIKAPU COUNTRY TOWN (WCT) DISTRICT FOR PROPERTY SITUATED AT WAILUKU, MAUI, HAWAII"

The propose of this bill is to amend Ordinance No. 4998 to allow: 1) additional residential workforce housing units to be provided in lieu of fulfilling certain change in zoning conditions; and 2) deed-restriction periods to be set for residential workforce housing units in Waikapu Country Town.

Bill 29 (2023) "A BILL FOR AN ORDINANCE AMENDING CHAPTER 19.96, MAUI COUNTY CODE, MODIFYING THE WAIKAPU COUNTRY TOWN DISTRICT CONTROLLING PLAN AND PERMITTING EDUCATIONAL USES IN THE RESIDENTIAL DISTRICT"

The purpose of this bill is to amend Chapter 19.96, Maui County Code, modifying the Waikapu Country Town District Controlling Plan to account for an exclusion in the original mapping and to allow for educational uses in the residential district to accommodate the potential expanded school site.

Bill 79 (2023) "A BILL FOR AN ORDINANCE AUTHORIZING THE MAYOR OF THE COUNTY OF MAUI TO ENTER INTO AN INTERGOVERNMENTAL AGREEMENT WITH THE DEPARTMENT OF TRANSPORTATION, STATE OF HAWAII"

The purpose of this bill is to authorize the Mayor to enter into an intergovernmental agreement with the Department of Transportation, State of Hawaii, for the purpose of operating and maintaining traffic signal hardware and other electrical equipment located at the intersection of Main Street and Church Street in Wailuku.

Bill 81, FD1 "A BILL FOR AN ORDINANCE AMENDING CHAPTER 11.03, MAUI COUNTY (2023) CODE, ESTABLISHING A FARE FREE BUS PASS PROGRAM"
