AND ALSO FROM THE DEPARTMENT OF THE CORPORATION COUNSEL IS CORPORATION COUNSEL VICTORIA TAKAYESU.\r\n\r\n>> BEFORE WE CALL ON MEMBER JOHNSON FOR OPENING REMARKS, MEMBERS, I JUST WANTED TO INTRODUCE TO YOU A VISITING COUNCIL MEMBER FROM O'AHU, CITY AND COUNTY OF HONOLULU, AND HE IS HERE TO OFFER HER -- SHE IS HERE TO OFFER HER ASSISTANCE TO ALL OF YOU, ALL OF US AND HER NAME IS VAL AQUINO OKIMOTO, IF YOU COULD PLEASE STAND AND SAY HELLO. WELCOME. >> THANK YOU. >> THANK YOU. AND NOW FOR OPENING REMARKS FROM COUNCIL MEMBER GABE JOHNSON. >> THANK YOU, CHAIR. COUNCIL MEMBERS, AND COMMUNITY MEMBERS, IF YOU WOULD ALLOW, I WOULD LIKE TO TAKE A MOMENT OF SILENCE FOR THE SOULS OF THOSE LOST IN THE LAHAINA FIRES.\r\n\r\n(MOMENT OF SILENCE TAKEN) MAHALO. AS MANY OF YOU MO I LIVE ON THE ISLAND OF LANA'I. HOWEVER, WHEN I CAME TO MAUI FOR MANY YEARS OF CAMPAIGNING AND NOW WORK ON OTHER REASONS, I WOULD OFFER STAY WITH MY COUSIN, JERRY WITH AND LIKE MANY OF YOUR FAMILY'S HOMES HIS HOUSE WAS ALWAYS OPEN TO ME AND EVEN MY DOG HOKU AND HIS DOG WAS ENTERING TO THE TERRACE PARK, I WOULD WORK HOKU THERE AND WE COULD SIT ON THE BLEACHERS AND WATCH THE KIDS PLAY SOFTBALL. THE PARK ALWAYS SMELLED OF FRESH CUT GRASS AND SOUNDS OF WORKING-CLASS NEIGHBORHOOD COULD BE HEARD ABOVE THE PINGING OF HOME RUN HIT. I REMEMBER GETTING THE GAMES I WOULD SEE THE KIDS WITH WALK BETWEEN CARS PARKED ON THE SIDE OF THE ROAD AND FELT CONCERN FOR THEIR SAFETY. A PEW YEARS BACK, DURING MY FIRST BUDGET SEASON, I ASKED COUNCIL MEMBER TAMARA PALTIN MAY WE COULD PUSH FOR SPEED TABLES TO BE INSTALLED ON THAT STREET. SHE AGREED WITH ME. NOW MY COUSIN'S HOME IS LEVELED, THE PARK'S GRASS IS BROWN, THE SHELLS OF BURNED CARS LAY ALONGSIDE THE ROAD.\r\n\r\nWE CAN'T GO IN THERE. NO ONE CAN GO IN THERE. IT'S ALL GONE. MY HEART HURTS. MY HEAD SWIRLS WITH EMOTION, RAGE, SADNESS, EMPATHY, I WANT TO GO BACK DO THOSE HOT LAHAINA NIGHTS AND SAVOR WHAT I NOW KNOW IS NO MORE. BUT THE REALITY SETS IN, GRIEVING COMES IN MANY STAGES, AND WHATEVER STAGE YOU'RE IN, IT'S THE CORRECT ONE. FOR ME, I'M HERE TO HELP I KNOW THIS BODY IS HERE TO HELP, TOO.\r\n\r\nWE HAVE WORK TO DO, MEMBERS. WHAT HAPPENED IS BEYOND DEVASTATING, AND FROM DAY ONE, WE HAVE BEEN HELPING THOSE AFFECTED BY THE FIRES. I HAVE HOPE. I HAVE SEEN HOPE, I HAVE SEEN US COME TOGETHER AS A COMMUNITY. CLERK. >> CHAIR, BEFORE YOU IS RESOLUTION 23-198, EXTENDING CONDOLENCES TO THE FAMILY OF THE LATE ROBERT "BOB" WARNER HOBDY. >> MEMBER JOHNSON. >> THANK YOU, I MOVE TO ADOPT RESOLUTION 23-198. >> MOVED BY MEMBER JOHNSON AND SECOND BY PRO TEM KAMA TO ADOPT RESOLUTION 23-198, DISCUSSION, MEMBER JOHNSON.\r\n\r\n>> THANK YOU, CHAIR. I WOULD LIKE TO CAN REQUEST THAT THE CLERK READ THE RESOLUTION IN ITS ENTIRETY. >> MS. CLERK. >> THANK YOU. EXTENDING CONDOLENCES TO THE FAMILY OF THE LATE ROBERT "BOB" WARNER HOBDY. WHEREAS, ROBERT "BOB" WARNER HOBDY PASSED AWAY ON JUNE 4, 2023 IN MAKAWAO AT THE AGE OF 81; AND WHEREAS, BOB IS SURVIVED BY HIS WIFE DOREEN, HIS SONS BRYON AND NATHAN, AND GRANDCHILDREN KEKOA, ELENA AND MALIA; AND WHEREAS, BOB WAS BORN ON SEPTEMBER 6TH, 1942 IN HONOLULU HAWAI'I TO WILLIAM WARNER HOBDY AND RUTH MARGARET BOYE HOBDY; AND WHEREAS, BOB ALONG WITH HIS ELDER BROTHER BILL BOYE HOBDY AND HIS YOUNGER SISTER ELIZABETH BETTY HOBDY MOVED TO LANA'I IN THE SUMMER OF 1950 WHEN THEIR FATHER TRANSFERRED FROM HONOLULU AS THE OFFICE MANAGER AND LATER SUMMIT WITH THE DOLE COMPANY; AND WHEREAS, BOB GREW UP SURROUNDED BY NATURE, AND EXPRESSED HIS KEEN INTEREST IN PLANTS AND BOTANY, STARTING AT THE AGE OF 15, WHICH LED TO OVER 40 YEAR'S OF WORK PROTECTING NATIVE AND ENDANGERED SPECIES AND THEIR HAWAIIAN HABITATS AND WHEREAS, BOB RECEIVED HIS DEGREE IN FORESTRY AT OREGON STATE UNIVERSITY AND WENT ON TO HAVE A CAREER IN THE HAWAI'I STATE DEPARTMENT OF LAND AND NATURAL RESOURCES. DLNR. DIVISION OF FORESTRY AND WILDLIFE. SPANNING MORE THAN 37 YEARS; AND WHEREAS, BOB MADE HIS WAY THROUGH THE RANKS AT DLNR, BEFORE RETIRING AS DISTRICT MANAGER OF MAUI COUNTY AND WENT ON TO BE ONE OF HAWAII'S LEADING ENVIRONMENTAL CONSULTANTS IN FLORA AND FAUNA, WETLAND AND WATERS IN THE UNITED STATES; AND WHEREAS, BETWEEN 2005 AND 2006, BOB HELPED TO CREATE A MABOF LANA'I FOR THE BOOK "STORY OF LANA'I" BY GEORGE C. MUNRO, CONTAINING A COLLECTION OF ALL KNOWN LANA'I PLACE NAMES THAT HAVE BEEN RECORDED DURING THE PAST 150 YEARS INTENDED TO

PROVIDE A WINDOW INTO THE ISLAND'S CULTURE AND LINK THAT CULTURE TO THE LAND, THE SEA AND THE HEAVENS WHICH IT IS SO INTIMATELY CONNECTED; AND WHEREAS, BOB HOPED THAT UPDATING OF THE MAP WOULD STIMULATE RENEWED INTEREST IN LANA'I'S MANY PLACE NAMES AND ENCOURAGE THE THEIR USAGE AS DESCRIPTORS OF THESE SPECIAL PLACES; AND WHEREAS, BOB FREELY AND HUMBLY SHARED HIS VAST KNOWLEDGE OF CONSERVATION ISSUES, HISTORY OF LAND MANAGEMENT. HIS ADVENTUROUS SPIRIT AND ENTHUSIASM TO EXPLORE AND LOCATE UNIQUE SPECIES INSPIRING HEARTS AND MINDS OF MANY PROFESSIONALS, INDIVIDUALS AND COMMUNITIES TO TAKE ACTION AND STEWARD HAWAII'S PRECIOUS SPECIES AND ECOSYSTEMS; AND WHEREAS, BOB LIVED ON MAUI FOR OVER 50 YEARS WHERE HE SERVED THE COMMUNITY BY VOLUNTEERING ON MANY BOARDS AS A MEMBER OR AN IN AN ADVISORY CAPACITY INCLUDING THE MAUI COUNTY ARBORIST ADVISORY COMMITTEE, MAUI INVASIVE SPECIES COMMITTEE, MAUI NUI BOTANICAL GARDENS, MAUNA-KAHALAWAI WATERSHED PARTNERSHIP, HAWAIIAN ISLANDS LAND TRUST, HILT AND FEDERAL WEED RISK ASSESSMENT COMMITTEE; AND WHEREAS, BOB WAS A NATURALIST AND CREDITED FOR DISCOVERING 12 SPECIES OF NATIVE HAWAIIAN PLANTS, FIVE OF WHICH ARE NAMED AFTER HIM BY OTHER BOTANISTS; AND WHEREAS, BOB WAS HONORED BY HILT IN 2020 AS "CHAMPION OF CHANGE OF THE LAND" FOR HIS SUBSTANTIAL IMPACT IN CONSERVATION AND SUSTAINABILITY AND AS A WAY TO EXPRESS HAWAII'S INDEBTEDNESS TO THE WAY HE WENT ABOVE AND BEYOND TO PROTECT WHAT IS SO UNIQUE TO HAWAI'I; AND WHEREAS, BOB DEDICATED HIS LIFE TO STUDY AND PROTECT HAWAII'S NATIVE ECOSYSTEM AND BECAME A DISTINGUISHED COMMUNITY CONSERVATION LEADER; AND WHEREAS, BOB IS REVERED FOR HIS CONTRIBUTIONS TO THE WORLD'S UNDERSTANDING NATIVE PLANTS; AND NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE COUNTY OF MAUI: 1, THAT THE COUNCIL EXPRESSES ITS GRATITUDE FOR THE LATE ROBERT "BOB" WARNER HOBDY'S HARD WORK AND DEDICATION FOR CARING FOR MAUI COUNTY'S LAND AND WILDLIFE AND 2, THAT THE COUNCIL EXTENDS ITS CONDOLENCES AND DEEPEST SYMPATHY TO THE FAMILY AND DEAR FRIENDS OF THE LATE ROBERT "BOB" WARNER HOBDY AND 3, THAT CERTIFIED COPIES OF HIS RESOLUTIONS BE TRANSMITTED TO HIS WIFE DOREEN HOBDY, HIS SONS BYRON HOBDY, AND NATHAN HOBDY; CHRIS BROSIUS, PROGRAM MANAGER, MAUNA-KAHALAWAI WATERSHED PARTNERSHIP; DAWN N.S. CHANG, CHAIRPERSON DEPARTMENT OF LAND AND NATURAL RESOURCES; AND THE HONORABLE RICHARD T. BISSEN, JR., MAYOR OF THE COUNTY OF MAUI.\r\n\r\n>> MEMBER JOHNSON, DISCUSSION. >> THANK YOU, CHAIR. MEMBERS, LIKE I MENTIONED IN MY OPENING REMARKS I KNOW THIS IS A TIME THAT WE'RE EXTENDING OUR CONDOLENCES TO SO MANY IN OUR COMMUNITY. IN LIGHT OF THE RECENT TRAGEDY, IT MAY SEEM LIKE ENOUGH TO EXTEND OUR CONDOLENCES TO FAMILY -- IT MAY NOT SEEM LIKE ENOUGH TO EXTEND OUR CONDOLENCES TO JUST ONE MAN, BUT IN TIMES OF CALAMITY, UNCERTAINTY AND RECOVERY, AS WE COME TOGETHER AS A COMMUNITY, I HAVE SEEN HOW MEANINGFUL TO HAVE A SENSE OF PURPOSE. KNOWING OUR PURPOSE INFORMS HOW WE BEST CAN HELP, IT KEEPS US MOVING FORWARD, EVEN IN TIMES OF HARDSHIP AND DESPAIR. WE CAN BE ENSURED TO DEEPEN OUR SENSE OF PURPOSE BY HONORING THE LIVES OF THOSE WE HAVE LOST AND THOSE WHO HAVE MADE LASTING IMPACTS ON OUR COUNTY THROUGH SERVICE. BOB HOBDY IS ONE SUCH MAN THAT LIFE HAS SERVED AS INSPIRATION, HE WAS INFLUENCED BY THE NATURE WHICH SURROUNDED HIM AND PURSUED A CAREER AS A NATURALIST WHICH SPANNED MORE THAN 40 YEARS.\r\n\r\nBOB RETIRED AS MAUI COUNTY DISTRICT MANAGER AS THE DEPARTMENT OF LAND AND NATURAL RESOURCES OUT OF HIS WORK HE WAS AN ENVIRONMENTAL CONSULTANT, NATURALIST, AND COMMUNITY VOLUNTEER. BOB IS REMEMBERED FOR HIS PASSION FOR THIS LAND AND PLACE, AND FOR LIVING A LIFE DEDICATED TO CARING FOR IT. HE IS REMEMBERED FOR SHARING THIS PASSION AND KNOWLEDGE WITH OTHERS, HELPING TO CULTIVATE THE NEXT-GENERATION OF ENVIRONMENTAL LEADERS. MEMBERS, BOB HOBDY'S CONTRIBUTIONS AND SERVICE TO OUR COMMUNITY ARE LONG-LASTING. I HOPE THAT IN OUR WORK AS PUBLIC SERVANTS, WE CAN ALSO MAKE A POSITIVE IMPACT THAT STANDS THE TEST OF TIME, AND I HOPE THE COMMUNITY CAN TAKE SOMETHING FROM THE MODEL OF BOB HOBDY'S LIFE AND DEEPEN OUR APPRECIATION AND CONNECTION TO THIS LAND AND THE NATURE WHICH MAKES THIS PLACE SPECIAL. I BELIEVE BOB WOULD APPRECIATE THAT. I EXTEND MY DEEPEST CONDOLENCES TO DOREEN HOBDY, BOB'S WIFE, AND THE REST OF BOB'S

FAMILY.\r\n\r\nTHANK YOU FOR SUPPORTING HIM IN HIS WORK, AND FOR SHARING HIM WITH OUR COMMUNITY. I ASK FOR THE MEMBERS' SUPPORT OF MY MOTION. >> THANK YOU, ANY MORE DISCUSSION? VICE-CHAIR -- LET THE RECORD SHOW VICE-CHAIR SUGIMURA IS PRESENT, AND YOU HAVE DISCUSSION? >> YES. THANK YOU. WE HAVE BEEN ALL OVER THIS ISLAND AND MY DAD WAS THE ONE WHO JUST DEDICATED HIS LIFE TO THIS ISLAND. THANK YOU. >> ALOHA MAI KAKOU. I WOULD LIKE TO OFFER A PRAYER ON BEHALF OF MAUI COUNTY AND THE DIFFICULTIES THAT WE'RE ALL GOING THROUGH. I WILL OFFER IT FIRST IN ENGLISH AND IN HAWAI'I. >> YOUR NAME? >> I AM BRYON HOBDY, SON OF ROBERT HOBDY.\r\n\r\nI WILL FINISH WITH IT IN A SMALL OLE, AND THEN I WOULD LIKE TO ASK IF OUR FAMILY COULD SING A PRAYER AFTER THAT AS WELL. ALL ARE HIS SERVANTS AND ALL ABIDE BY HIS (HAWAIIAN PRAYER) [APPLAUSE] >> MY GOODNESS, THAT WAS SO BEAUTIFUL. DO WE HAVE ANYTHING TO GIVE THEM?\r\n\r\nNO? NO. DID YOU WANT US TO TAKE A PICTURE WITH THEM? YOU DO? CAN YOU COME BACK DOWN, PLEASE? MEMBERS, PLEASE. O. F CITIZEN REVIEW BOARD. THERE'S NO BUSINESS. G. PRESENTATION OF WRITTEN OR ORAL TESTIMONY AT THIS TIME INDIVIDUALS MAY TESTIFY ON ANY ITEM ON THE AGENDA.\r\n\r\nTHE FIRST PERSON TO TESTIFY IS CALLING FROM THE PHONE NUMBER ENDING IN 6621. THIS IS YOUR OPPORTUNITY TO TESTIFY. IF YOU COULD PLEASE LET US KNOW WHAT SUBJECT YOU WILL BE TESTIFYING ON. >> ALOHA, I WILL BE TESTIFYING ON BILL 83. CAN YOU HEAR ME OKAY? >> YES. YOUR NAME? >> THANK YOU. MY NAME IS NAPUA, THE ADMINISTRATOR AND COORDINATOR FOR HANA HIGHWAY, AHUPUA'A COUNCIL OF MAUI COUNTY RESIDENTS, WHO FIRMLY OPPOSE THE ATTEMPT TO AMEND THE FISCAL YEAR 2024 BUDGET TO DELETE CONDITIONAL LANGUAGE STATING THE TOURISM MANAGEMENT GRANT FUND MA NOT BE USED FOR MARKETING AND PROMOTION BUT FOR EDUCATION EFFORTS.\r\n\r\nVISITOR MANAGEMENT AND EDUCATION FUNDS SHOULD BE SPENT ON FIRST AND HANA HIGHWAY REGULATION OBJECTS TO ANY FUNDS BEING AWARDED TO THE MAUI CONVENTION BUREAU AS THEY HAVE FAIL THE COMMUNITY TIME AND TIME AGAINST. THERE'S BEEN NO FOLLOW-UP THROUGH OF THE EAST TOURISM MAUI PROGRAM, WHICH IS CONSIDERED A FAILURE AS ITS BEING LEAD WITH EXECUTIVES WITH NO HISTORICAL CONTEXT AND -- VISITOR MANAGEMENT FUNS IN THE FORMS OF CONTRACTS TO PERSONAL FRIENDS AND COLLEAGUES OVER COMMUNITY RELEVANT SUBJECT-MATTER EXPERTS. VISITOR

FUNDS TO DATE HAVE BEEN EXPENDED ON ACTUAL METHODS OF VISITOR MANAGEMENT, AND VISITOR EDUCATION, WE WOULD HAVE A SYSTEM IN PLACE TO TRACK THAT INFLUX OF TOURISM WOULD BE DELEGATED PROPERLY, INSTEAD WE'RE CONTINUALLY LEFT WITH NO SUPPORT FOR RESIDENT-LED OR MANAGED TOURISM. DESPITE THE FACT THAT OUR ORGANIZATION HAS DESCRIBED A SOLUTION THAT HAS PROVEN ITS EFFICACY SINCE 2018. ONE HAS TO ASK, WHERE HAS ALL THE VISITOR MANAGEMENT EDUCATION FUNDS GONE? SO WE ASK FORMALLY AND YET TO-DATE HAWAIIAN TOURISM AUTHORITY AND MCDC HAVE FAILED TO PROVIDE INFORMATION REQUESTED BY OUR ORGANIZATION IN A TIMELY MANNER AND WOULD REVEAL PLAIT AN CONFLICTS OF INTEREST MANY HOW GOVERNMENT MONIES HAVE BEEN EXTENDED BY THESE ORGANIZATIONS AND CONFIRM THAT THE CONTINUED RELIANCE ON INFORMATION MARKETING STRATEGIES DISADVANTAGES ECONOMIC OPPORTUNITIES FOR THE LOCAL PEOPLE TO PARTICIPATE IN VISITOR MANAGEMENT, AND CONTINUES TO POSE HARM TO VISITORS IN THE FORM OF LACK OF VISITOR EDUCATION WHICH LEADS TO VISITOR INJURIES AND FATALITIES. OUR ORGANIZATION HAS BEEN PROVIDING FORMAL NOTICE REGARDING THE LOOMING LIABILITIES OF HAVING NO SOUND VISITOR EDUCATION PROGRAM IN PLACE. TO THE GOVERNMENT INFORMATION BE REQUESTED IT WOULD DETAIL THE FUNDING OF GOVERNMENT FUNDS TO NONPROFITS WHOSE BOARD MEMBERS CONSIST OF EMPLOYEES AND HTA STEERING COMMITTEE MEMBERS.\r\n\r\nTHE REQUESTED INFORMATION WOULD REVEAL THAT THOSE VISITOR INDUSTRY EXECUTIVES WHO ARE SETTING THE DESTINATION MANAGEMENT ACTION PLAN PRIORITIES AT THE TOP ARE ALSO POSITIONING THEMSELVES AND THEIR ORGANIZATIONS TO TAKE ADVANTAGE OF THESE FUNDING PRIORITIES AT THE BOTTOM. MAYI DOESN'T NEED FURTHER COMMOTION AND MARKETS ITSELF. MAUI DOES HOWEVER NEEDS INJURY AND FATAL INJURY INTERVENTION AND AS A LACK OF VISITOR MANAGEMENT AND EDUCATION WILL CONTINUE TO ERODE MAUI AND MANAGEMENT FUNDS ARE MARKETING MAUI AS RECKLESS. >> THREE MINUTES. >> CAN YOU PLEASE CONCLUDE. >> SURE. AND ALSO THE GOVERNMENT OFFICIALS FOR LAST SIX YEARS HAVE BEEN CARRYING THAT NARRATIVE OF THE NEED FOR VISITOR MANAGEMENT AND VISITOR EDUCATION.\r\n\r\nSO I WOULD PLEASE ASK THERE BE NO MONEYS EXPENDED ESPECIALLY TO MCDC FOR THE PURPOSE OF MARKETING MAUI. OPEN TO QUESTIONS IF THERE ARE ANY. MAHALO. >> QUESTIONS? WE'LL START WITH PRO TEM KAMA AND MEMBER SUGIMURA. >> THANK YOU, CHAIR, I WANTED TO CLARIFY, THAT YOU ARE TESTIFYING ON BILL 83, WHICH IS THE ORDINANCE AMENDING SECTION 19.47 OF THE COUNTY CODE RELATING TO WETLANDS AND OER LANDS MAPPING. BUT I THINK YOU WERE TESTIFYING ON BILL 84. THE BILLS THAT AMENDS THE BUDGET FOR GRANTS AND DISBURSEMENTS FOR VISITOR INDUSTRY, IS THAT CORRECT?\r\n\r\n>> CORRECT. I APOLOGIZE IF I GOT THE BIG NUMBER INCORRECT. >> THANK YOU. THANK YOU, CHAIR. >> THANK YOU FOR THE CLARIFICATION. VICE-CHAIR SUGIMURA. >> THAT WAS MY SAME CLARIFICATION.\r\n\r\nTHANKS. >> MET ME ADD ANOTHER ONE, THE CHAIR MYSELF WAS GOING TO RECOMMEND NO FLOOR ACTION TODAY AND REFERRAL TO. MEMBER PALTIN. >> >> I HAD THE SAME CLARIFICATION AS KAMA AND SUGIMURA. >> ANYONE ELSE? THANK YOU. >> MAHALO.\r\n\r\n:NEXT TESTIFIER? >> CHAIR. THE NEXT TESTIFIER IS JENN MATHER TESTIFYING ON BILL 84. >> ALOHA, COUNCIL CHAIR LEE AND HONORABLE COUNCIL MEMBERS. >> EXCUSE ME, MS. MATHER, THE OTHER MICROPHONE IS NOT WORKING. THAT IS WHY THEY GAVE YOU THAT ONE. >> MAHALO. SO MANY NAME IS JENN MATHER, TESTIFYING ON AGENDA ITEM BILL 84. I OPPOSE THE AMENDMENT TO THE BUDGET FOR THE TOURISM MANAGEMENT GRANT FUND OF \$550,000 OF WHICH \$300,000 IS FOR MOLOKA'I LEAVING THE AMENDMENT -- ASK FOR THE REMAINING \$250,000. UNLIKE AUTUMN NES SAID LAST COUNCIL MEETING I'M NOT ANG CONSPIRACY THEORIST EITHER, BUT I SEE THE MERITS IN WHAT PEOPLE ARE SAYING WHAT B WHAT IS HAPPENING IN THE CHAMBERS, AT THE CAPITOL AND IN MEETINGS HELD THROUGHOUT THE PAI'AINA AND IT APPEARS ORCHESTRATED TO ROLL BACK THE GROWING WE HAVE MADE AS LARGE HUI AND COMMUNITY AND WONDERING WHY WE ALWAYS NEED TO BE THE OMBUDSMEN WATCHDOGS OF GOVERNMENT AND AFTER FOUGHT SO HARD FOR OUR COMMUNITY FIRST DEVELOPERS LIKE PAUL CHANG AND -- WHEN WE FINALLY HAD WATER PROTECTION THROUGH ENFORCED WATER MANAGEMENT DESIGNATION FOR LAHAINA, AND NOW THIS, ROLL BACK THE MEASURES FOR TOURISM MANAGEMENT WE HAVE BEEN ADVOCATING FOR AND MOVING BACK TO WHAT IS MARKETING A GRIEVING COMMUNITY.\r\n\r\nIT SHOULD NOT BE MAUI COUNTY'S TAX MONEY THAT

GOES TO MARKETING AND SHOULD BE THE RESORTS THAT DO THE HEAVY LIFTING RECOGNIZE THEIR CORPORATE DOLLARS AND REACH HAVE MORE CAPABILITY ABILITIES CAPACITY DO THIS RIGHT NOW FOR YOU. IF YOU FOLKS STILL CONTINUE TO BELIEVE THAT WE HAVE TO BE A SINGLE-ENGINE ECONOMY DRIVEN BY TOURISM, I THINK YOU SHOULD MANDATE THAT THE CORPORATE ENTITIES THAT ARE GETTING THOUSANDS OF DISASTER DOLLARS RIGHT FROM YOU FROM RESPONDERS STAYING WITH THEM BE PART OF THE TOURISM SOLUTION AND NOT THE MONEY EARMARKED FOR TOURISM MANAGEMENT. I'M NOT JUST TALKING ABOUT FEDERAL FEMA MONEY. WHEN WE ASK FOR ROOMS THAT CAME AS PART OF THE NONPROFIT, TOLD YOU CAN, BUT YOU HAVE TO PAY \$650 A NIGHT PLUS FEES AND TAXES AND I DON'T KNOW WHY THEY ARE CRYING POOR WHEN THEY ARE HERE TO HELP ASSIST. FOR THE MONEY AND TOURISM MANAGEMENT FUND, WITH NEED THAT MONEY RIGHT NOW FOR THAT PURPOSE MORE NOW THAN EVER; RIGHT? WEST MAUI NEEDS ADVOCATES FOR PROTECTION, FOR HEALING AND REBUILDING. SO WE NEED TO USE THAT MONEY AS INTENDED TO TELL VISITORS TO STAY OUT.\r\n\r\nLAHAINA HAS ALWAYS BEEN SACRED, BUT NOW SHE IS JUST A MASS BURIAL GROUND, TOO. THAT MESSAGING IS IMPERATIVE AND NEEDS MONEY TO GET OUT THERE. THAT MONEY IS ALREADY EARMARKED IN THAT PURPOSE, NOT FOR INVITING PEOPLE TO TELL THEM HOW TO BE GOOD HUMANS WHEN HERE. YOU HOPE THAT WOULDN'T BE NECESSARY, BUT DISPATCH ERA DARK TOURISM HAS BEEN A REAL THING SINCE MOUNT VESUVIUS AND ASK YOU TO DO THE HUMANE THING AND OPPOSE THIS BILL, EVEN IN COMMITTEE. COMMUNICATIONS 23-33. I WOULD LIKE TO BE THE FIRST TO VOTE FOR YUKI LEI SUGIMURA AS STATE SENATOR, BECAUSE SHE DOES A GOOD JOB HERDING CATS, CHICKENS, AXIS DEER AND ROWDY HULA MONKEYS.\r\n\r\nTHANK YOU FOR YOUR TIME. >> CHAIR, WE'LL GO BACK ONE MORE TIME AND SEE IF MS. PCOLA-DAVIS IS. I CAN SEE HER ON THE SCREEN, BUT LOOKS LIKE SHE IS MUTED ON HER END. MS. PCOLA-DAVIS. >> HI.\r\n\r\nI THINK YOU CAN HEAR ME NOW? >> YES. >> CAN YOU HEAR ME NOW? >> YES, WE CAN. >> THANK YOU. I AM -- TESTIFYING ON CC 2023-KULA COMMUNITY. AND I'M TESTIFYING BECAUSE I DO NOT THINK THAT THIS REPORT BE POSTPONED UNTIL THE NEXT MEETING.\r\n\r\nHOWEVER, I DO UNDERSTAND IT'S PREPARED ALREADY. THE REASON I AM SAYING THIS IS BECAUSE OF HEALTH AND SAFETY. I DID SUBMIT WRITTEN TESTIMONY, AND SOME OF THE THINGS THAT I THINK ARE REALLY IMPORTANT RIGHT NOW IS THE WATER QUALITY AND TESTIFYING FOR HYDROCARBON LEVELS. I HAVE WATCHED THE LAB RESULTS FROM THE BOARD OF WATER SUPPLY, AND I'M WATCHING THE LABS ONLY BECAUSE MY BACKGROUND IS FOLLOWING RESEARCHING THE FUEL TANK STORAGE WATER DISTRIBUTION SYSTEM AND VERY FAMILIAR WITH READING THE LAB REPORTS. THE AIR QUALITY ARE WHAT CONTAMINANTS ARE TESTING FOR. YOU SHOULD GO BACK HOME AND CHECK YOUR AIR CONDITIONER FILTERS. ESPECIALLY IF THEY ARE WINDOW AIR CONDITIONERS. IF YOU HAVE SPLIT AIR, PLEASE HAVE SOMEONE COME OUT AND CHECK IF THEY NEED CLEANING?\r\n\r\nI WAS ON MAUI D MAYBE IT WAS YESTERDAY? WITH THE DEPARTMENT OF EDUCATION MEETING. I HAD TO USE MY INHALER FOUR TIMES. NEVER HAPPENED TO ME IN MY LIFE. I HAVE GOTTEN FROM O'AHU AND STILL USING MY INHALER, BECAUSE OF MY LUNGS. I CAN BARELY BREATHE. MY EYE CLASSES WERE SO COATED WITH SOME KIND OF FILM AT THE KAHULUI AIRPORT, I HAD TO GO INTO THE BATHROOM AND WASHING WITH SOAP AND WATER.\r\n\r\nSO THERE'S SOMETHING GOING ON OVER THERE. AS YOU KNOW, SOIL QUALITY, THE DIOXINS NEED TO BE TESTED FOR AND I HEARD THEY ARE BEING TESTED FOR AND SENT TO THE MAINLAND AND MAY TAKE A WHILE TO GET BACK DUE TO THE TYPE OF TESTING. I HAVEN'T HEARD ANYBODY TALK ABOUT THE STATUS OF AQUIFER AND, IN FACT, YOUR WATER SOURCES WATER FLOWS UNDERGROUND AND GROUNDWATER NEEDS TO BE TESTIFIED, TOO. WHAT IS IN THE AIR? I THINK THE COUNTY SHOULD RAISE AWARENESS BY AIR QUALITY. MASKS AND OTHER PPE ARE BEING MADE AVAILABLE FOR FREE. SECONDED BY VICE-CHAIR SUGIMURA TO PASS BILL 79 ON SECOND AND FINAL READING. ANY DISCUSSION? MEMBER COOK?\r\n\r\n>> THANK YOU, CHAIR. BILL 79 ESTABLISHES AN INTERGOVERNMENTAL AGREEMENT WITH THE STATE THAT WILL GRANT RIGHT-OF-WAY ACCESS TO MAINTAIN, OPERATE THE TRAFFIC SIGNAL HARDWARE AT THE INTERSECTION OF MAIN STREET AND CHURCH STREET IN WAILUKU, MAUI. I RESPECTFULLY ASK FOR THE MEMBERS' SUPPORT OF MY MOTION. >> ANY MORE DISCUSSION? ALL THOSE IN FAVOR OF THE MOTION, RAISE YOUR HAND, SAY AYE? >> AYE. >> NINE AYES, ZERO NOS, OKAY.\r\n\r\nMOTION CARRIES. MS. CLERK. >> CHAIR YOU BEFORE YOU BILL 81, FD 1 (2023) A BILL FOR AN ORDINANCE AMENDING CHAPTER 11.03 MAK MID-ATLANTIC CODE ESTABLISHING A FARE FREE BUS PASS PROGRAM. >> MEMBER JOHNSON. >> THANK YOU, CHAIR, I MOVE TO PASS BILL 81, FD 1 ON SECOND AND FINAL READING. >> SECOND.\r\n\r\n>> MOVED BY MEMBER JOHNSON AND SECOND BY MEMBER KAMA TO PASS BILL 81, FD 1 (2023) ON SECOND AND FINAL READING. MEMBER JOHNSON. >> THIS COUNCIL APPROVED MY BUDGET REQUEST TO APPLY FARE FREE BUS FOR ANY 55 YEARS OR OLDER, PARATRANSIT ELIGIBLE, AND VALID STUDENT CARD AND 24 YEARS OR YOUNGER OR DEMONSTRATING FINANCIAL NEED. THIS IS ALREADY IN THE BUDGET. BILL 81 ADDS LANGUAGE SAYING THAT A PERSON CAN DEMONSTRATE FINANCIAL NEED SHOWING THAT THEY ARE MAUI COUNTY RESIDENT WHOSE HOUSEHOLD INCOME IS EQUAL OR LESS TO 200% OF THE POVERTY THRESHOLD AND ALLOWS THE DEPARTMENT TO CONTRACT WITH THE THIRD-PARTY TO VERIFY INFORMATION. THIS BILL IS DESIGNED TO ENCOURAGE PEOPLE OF LIMITED MEANS TO USE PUBLIC TRANSPORTATION, WHICH IS A SAFE WAY TO TRAVEL AND CONNECT OUR COMMUNITIES. ACCORDING TO A 2021 STUDY BY HUL PONO INITIATIVE THE COST TO ENON A VEHICLE ON HAWAI'I IS \$1800 ANNUALLY WHEN FACTORING GAS, MAINTENANCE AND INSURANCE, IT'S NOT CHEAP AND THE FARE FREE BUS PASS WILL HELP THOSE WITH CRITICAL TRANSPORTATION TO GO TO WORK, SHOP, MEDICAL APPOINTMENTS AND SOCIAL SERVICE ORGANIZATIONS.\r\n\r\nPLUS WE AS A COMMUNITY ALL BENEFIT FROM LESS CARS ON THE ROAD, THE MORE PEOPLE THAT ACCESS THE PUBLIC TRANSPORTATION VIA THIS FARE FREE BUS PASS, THE LESS CARS CLOGGING OUR ROADS FILLING OUR PLATFORMS AND EMITTING GREENHOUSE GAS AND HAS BEEN SIGNED OFF BY CORPORATION COUNSEL AND WITH THE DEPARTMENT OF TRANSPORTATION. I ASK FOR MEMBERS' SUPPORT OF MY MOTION. >> ANY MORE DISCUSSION? MEMBER PALTIN. >> THANK YOU. AT THIS TIME, THIS IS SO CRITICAL, AND NEEDED. BECAUSE SO MANY OF OUR RESIDENTS LOST THEIR TRANSPORTATION ALTHOUGH OUR OWN COUNTY DEPARTMENT OF TRANSPORTATION HASN'T BEEN ABLE TO STEP UP FOR OUR RESIDENTS SHELTERING AT THE HOTELS. THERE WASN'T ANY ACTION. >> DAVID? >> THANK YOU, CHAIR. I WOULD DEFER TO THE COUNTY CLERK, IF SHE HAS A DIFFERENT IDEA? WE WOULD NORMALLY REGARD THE REFERRAL AS A FORM OF ACTION.\r\n\r\nSO RECONSIDERATION WOULD BE IN ORDER. THANK YOU. >> MEMBER RAWLINS-FERNANDEZ. >> I MOVE FOR A RECONSIDERATION ON BILL 84. >> SECOND. >> MOVED BY REMEMBER RAWLINS-FERNANDEZ, SECOND BY MEMBER PALTIN TO RECONSIDER ACTION ON BILL 84. DISCUSSION, MEMBER RAWLINS-FERNANDEZ. >> MAHALO, CHAIR. SO NEW INFORMATION WAS JUST SHARED WITH ME FROM OUR OFFICE OF ECONOMIC DEVELOPMENT DIRECTOR THAT HAWAIIAN TOURISM AUTHORITY RELEASED \$2.6 MILLION YESTERDAY TO HELP WITH MARKETING -- OH, OKAY.\r\n\r\nDID YOU SAY DIFFERENT NUMBER? 2.6 MILLION. MORE? OH, OKAY. >> THAT'S

CORRECT. I WATCHED TV LAST NIGHT. >> OKAY.\r\n\r\nSO WE'RE GETTING THUMB'S UP. GOOD. SO THERE IS FUNDING FOR THE HELP WITH MARKETING THAT THE PUBLIC BUSINESS OWNERS, AND OTHER PARTS OF MAUI ARE ASKING FOR. YOU KNOW, I ALSO WANT TO ENSURE OUR COMMUNITY THAT WE ALSO HEAR THE PROGRESS THAT WE HAVE MADE IN WORKING TOWARDS MANAGEMENT. I EMAILED THE MAUI VISITOR'S BUREAU TO ASK WHAT IS THEIR PLAN, THE NEW BUDGET ON DETAILS OF PAID MEDIA? SO PAID ADVERTISING WHICH IS THE INTENT FOR THE MARKETING PROGRAM. AS OUR TESTIFIER STATED WE ALSO DO NEED MANAGEMENT.\r\n\r\nLIKE, WE'RE NOT GOING TO JUST SAY COME HERE. WE'RE NOT DOING BRAND DEVELOPMENT RIGHT NOW. HAWAI'I HAS A -- -- MAUI SPECIFICALLY HAS A STRONG BRAND. SO IT'S NOT BRAND DEVELOPMENT. IT'S MORE EDUCATING TOURISTS THAT THEY CAN COME TO OTHER PARTS OF MAUI. DON'T GO TO WEST MAUI AND WHEN YOU DO COME, PLEASE BE SENSITIVE. SO I THINK THERE'S A NECESSARY COMPONENT FOR MANAGEMENT AND EDUCATION IN THE PAID MEDIA PAID ADVERTISING AND PROMOTION.\r\n\r\nMAHALO.? >> AYE. LIKE I SAID, YOU CAUGHT ME ON A GOOD DAY. WE'RE ONLY TALKING ABOUT THE RECONSIDERATION AND NOT DISCUSSION OF THE ENTIRE ITEM. BUT NOW EVERYBODY KNOWS WHY SHE IS MAKING THE MOTION. SO NOW WE'RE GOING TO TAKE A VOTE ON THE RECONSIDERATION. RIGHT? >> YES.\r\n\r\n>> MEMBER PALTIN ON THE RECONSIDERATION. >> YES. SORRY, I WAS ABLE TO WATCH TELEVISION LAST NIGHT AND I DID HEAR THAT ON THE NEWS AS WELL. BUT I DIDN'T CONNECT THE DOTS IN TIME ON THE REFERRAL. SO I'M SUPPORTIVE OF THE RECONSIDERATION. >> DID YOU SAY, MEMBER RAWLINS-FERNANDEZ, THAT THE OFFICE OF ECONOMIC DEVELOPMENT DIRECTOR NOTIFIED YOU. >> IS ON.\r\n\r\n>> THAT -->> YES. >> THAT THEY NO LONGER ARE SUPPORTING THE AMENDMENT FOR BILL 84? >> I DIDN'T ASK -- -- OH, NO. MAHALO, CHAIR. >> MEMBER PALTIN. >> I JUST WANTED TO ADD THAT YOU KNOW, WITH THE MONEY GOING TO HTA, THE \$2.6 MILLION, I THINK THE IMPORTANT THING FOR US AT MAUI COUNTY IS TO WORKING ON THAT MESSAGE, IF THE IMPORTANT THING IS JOBS. AND IT'S ALSO IMPORTANT TO MANAGE IT, PART OF THE REASON TOURISM SLOWED DOWN ON ALL OF MAUI IS SOME OF OUR INFLUENCERS SEEING WHAT HAPPENED THREE DAYS AFTER THE FIRE.\r\n\r\nSO IF OED, OR THE CHAMBER, OR

WHOMEVER WORKS COLLABORATIVELY WITH OUR COMMUNITY ON THE MESSAGE ABOUT THE NEED FOR JOBS, AND TOURISM IN AREAS THAT CAN HANDLE IT, I THINK WE CAN WORK WITH THE INFLUENCERS TO GET THAT MESSAGE OUT AS WELL, AND KEEP THAT \$75,000 TO MANAGE THE TOURISTS WHEN THEY COME, BECAUSE NOT ALL OF THEM FOLLOW DIRECTIONS. >> I GUESS I JUST HAVE TO GO ON THE ROAD AGAIN. DO YOU KNOW I DID 26 INTERVIEWS AND MOST OF THEM WERE NATIONAL AND INTERNATIONAL? I KNOW PEOPLE ON A FIRST NAME BASIS IN ISTANBUL, TURKEY. MEMBER SINENCI. >> MAHALO, CHAIR FOR MY OPPORTUNITY AND MAHALO TO MEMBER RAWLINS-FERNANDEZ FOR THE MOTION. I JUST WANTED TO REITERATE MS.\r\n\r\nSWAIOL'S TESTIMONY THAT EAST MAUI, WE WANT TO BE VISITOR - -- VISITOR SAFETY IS ONE OF OUR ISSUES AND PART OF THE MESSAGING SHOULD BE THAT FOR RURAL COMMUNITIES THAT HAVE LIMITED RESOURCES, FOR EMT PERSONNEL, WE WANT TO MAKE SURE OUR VISITORS ARE VISITING THOSE PLACES THAT HAVE APPROPRIATE FACILITIES ALREADY IN PLACE. SO HAPPY TO SUPPORT MORE MANAGEMENT. THANK YOU. CHAIR. >> THANK YOU. I DID SPEAK WITH MEMBER -- NOT MEMBER. BUT DIRECTOR MAHI ABOUT THIS YESTERDAY. AND SHE DID ASSURE ME THAT THE MONIES THAT MVB WERE DISCUSSING HAD MOG NOTHING TO DO WITH OTHER NON-PROFITS OR ANOTHER FOLKS THAT HAVE APPLIED FOR FUNDING. AM I CORRECT, DIRECTOR MAHI?\r\n\r\nDO YOU WANT TO EXPAND ON THAT? >> YES, THEIR GRANT WAS FOR A VERY SPECIFIC PURPOSE, AND DESTINATION MANAGEMENT ONE, AND ALSO, WE AGREED TO PAY FOR THEIR BROCHURES THAT WERE CREATED THAT COVERED SPECIFICALLY LANA'I, MOLOKA'I, AND EAST MAUI. >> OKAY. >> WHEN I MENTIONED EARLIER, FOLKS, I WAS ON THE ROAD, ON SEVERAL NATIONAL TV STATIONS, I TALKED ABOUT MAUI IS NOT ON FIRE. FOR SOME REASON, THEY WANT TO SAY MAUI IS ON FIRE. THAT NEEDED CLARIFICATION AND ME AND OTHER PEOPLE TRIED TO MAKE THAT CLARIFICATION. MEMBER PALTIN.\r\n\r\n>> I KIND OF WAS REFERRING TO OTHER INFLUENCERS THAT -- [LAUGHTER] THAT HAVE A BROADER FOLLOWING. >> OKAY. I WENT ON ABC, CNN, EVERY SINGLE MAJOR STATION IN THE UNITED STATES OF AMERICA. OKAY? PRO TEM KAMA. >> THANK YOU, CHAIR. JUST KNOW THAT YOU HAVE SOME INFLUENCE IN THIS CHAMBER.\r\n\r\nBUT I JUST WANTED TO SAY THAT I THANK DIRECTOR MAHI FOR WHAT SHE SAID, BECAUSE THE ECONOMY IS VERY IMPORTANT. WHILE LAHAINA IS OUR GREATEST CONCERN, BUT BEYOND LAHAINA, ALSO ARE OTHER BUSINESSES THAT ARE SUFFERING, AND THEY ARE LOOKING FOR DIRECTION FROM US, AND WHAT IS THAT MESSAGE GOING TO BE? THAT THEY ARE GOING TO BE EXCLUDED FROM THE MESSAGING? THAT HTA IS GOING TO SEND OUT? SO DOES THAT MEAN THAT EVERYBODY BEYOND LAHAINA DOESN'T GET TO ENJOY THEIR BUSINESSES, OR THE TOURISTS THAT USED TO GO TO MAYBE THE KANA AREA OR BEYOND THAT? >> IS THAT A QUESTION FOR DIRECTOR MAHI? >> YES.\r\n\r\n>> OKAY. >> DIRECTOR MAHI, DID YOU HEAR THE QUESTION? >> YES. IN REGARDS TO MARKETING OR IN REGARDS TO THE PLANS FOR THE BUSINESSES THAT WERE DIRECTLY OR INDIRECTLY IMPACTED? >> YES. >> BOTH. >> SO WE DO HAVE A PLAN THAT I'M WORKING ON WITH A COUPLE OF NONPROFIT ORGANIZATIONS, AND WE'RE HOPING TO GET ALL OF THAT FINALIZED TODAY.\r\n\r\nSO WE CAN ISSUE A PRESS RELEASE FOR OUR BUSINESSES THAT HAVE BEEN IMPACTED. AND THEY WILL HAVE A PLACE TO GO FOR SPECIFICALLY GRANT FUNDING. KNOWING THAT MANY OF THEM DURING COVID HAD TAKEN ON COVID LOANS, OR EID L LOANS MANY DON'T QUALIFY FOR ANOTHER SBA LOAN. SO WE'RE LOOKING AT PRIMARILY GRANT FUNDING FOR THEM. >> WHAT WOULD THE MESSAGING BE TO THEM, IF THE MESSAGE TO THE TOURISTS IS DON'T GO TO THE WEST SIDE, BUT STAY ON CENTRAL AND SOUTHSIDE? >> WELL, LIKE I MENTIONED, THE IMPORTANCE IS TO BRING OUR VISITORS BACK IN A RESPECTFUL AND SENSITIVE WAY. SO THAT THEY CAN PUT OUR PEOPLE BACK TO WORK.\r\n\r\nI THINK THE FRIDAY BEFORE THE FIRE, WE HAD, I BELIEVE 121 PEOPLE ON UNEMPLOYMENT, AND AS OF LAST WEEK FRIDAY, OVER 4,000 HAVE APPLIED. I WILL BE GETTING AN UPDATE ON THAT TODAY. SO I KNOW THAT WITH MY WORKFORCE DEVELOPMENT CREW THAT HAS BEEN AT HYATT REGENCY AND UH MAUI HUB, THEY HAVE A WAITING LIST OF PEOPLE THAT NEED HELP AND SERVICES WITH NOT JUST UNEMPLOYMENT BENEFITS, OR DOA, WHICH IS IN PLACE OF PUA DURING COVID. BUT WITH SNAP BENEFITS, GENERAL ASSISTANCE. SO OUR OFFICE IS TRYING TO BRING THEM ALL OF THE RESOURCES THAT WE CAN TO HELP EVERYBODY. >> I'M JUST HOPING THAT THE PEOPLE ON THAT SIDE WITH THEIR BUSINESSES WILL BE OKAY. THANK YOU, CHAIR.\r\n\r\n>> DON'T FORGET WE'RE ON THE RECONSIDERATION -- NOT THE RECONSIDERATION, BUT THE FILING OF BILL 84. MEMBER

JOHNSON. >> THANK YOU, CHAIR. I WOULD SUPPORT THE FILING. YOU KNOW, I'M A STRONG ADVOCATE FOR BETTER PAYING JOBS, QUALITY OVER QUANTITY, I USED TO WORK IN THE RESORTS. I KNOW THE FRONT OF THE HOUSE MAKES A DECENT LIVING, BUT THE BACK OF THE HOUSE DOESN'T; RIGHT? WE OFTEN HEAR THE UNIONS SAY ONE JOB SHOULD BE ENOUGH, AND THAT IS A LOT OF REASON WHY OUR UNEMPLOYMENT IS SO LOW, BECAUSE WE'RE WORKING TWO JOBS. I SEE SO MANY PEOPLE WHO ARE ALICE, YOU KNOW, ALICE HOUSEHOLDS ARING, ING WORKING, BUT NOT MAKING GOOD MONEY AND THIS DISASTER UNFORTUNATELY MAYBE FORCES OUR HAND TO PIVOT TO BETTER-PAYING JOBS, OTHER WAYS, HAVING A MORE DIVERSE ECONOMY.\r\n\r\nAND I THINK THAT IS KIND OF WHY I WANT TO LOOK THROUGH THIS LENS, THROUGH THIS WITH THE LENS OF OKAY, IN TIMES OF DISASTER, WE HAVE TO BE NIMBLE, AND MAYBE LOOK AT OTHER WAYS, OTHER CAREERS THAT ACTUALLY COULD END UP HELPING OUR COMMUNITY. SO I SUPPORT THE FILING. THANK YOU, CHAIR. >> ANYBODY ELSE? MEMBER COOK. >> I JUST WANT TO SPEAK ON BEHALF OF MY COMMUNITY. SO MANY PEOPLE HAVE BEEN LAID-OFF IN MY NEIGHBORHOOD.\r\n\r\nGETTING RESERVATIONS AT RESTAURANTS IS DIFFICULT, BECAUSE THEY ARE CUTTING BACK ON HOURS. THERE IS FEAR AND CONCERN ABOUT BEING ABLE TO PAY RENT, BILLS, UTILITIES, AND WE DO NEED TO EDUCATE OUR TOURISTS AND VISITORS, AND ADVOCATE THAT THEY COME BACK, WITH SENSITIVITY. BUT WE NEED THEM BACK, OTHERWISE, WE'RE GOING TO HAVE MASSIVE UNEMPLOYMENT WITH VIRTUALLY NO OTHER SUPPORT. THANK YOU. >> ANYBODY ELSE? VICE-CHAIR SUGIMURA. >> MYSELF AND TAMARA PALTIN ARE LIVING DAILY, MINUTE-BY-MINUTE, THIS DISASTER.\r\n\r\nI WILL TELL YOU THAT WE DO NEED OUR MAIN ECONOMIC DRIVER BACK TO COME AND HELP SUPPORT AND LIFT THE COMMUNITY. VERY SENSITIVELY, I THINK THEY KNOW THE PAIN, BECAUSE I HAVE BEEN GETTING EMAIL MESSAGES FROM OUR NACO COUNTERPARTS, FINANCIAL DONATIONS, I MEAN, AMAZING, COMING FORWARD TO SUPPORT US. I REALLY APPRECIATE IT. I DO FEEL STRONGLY THAT WE NEED OUR VISITOR COMPONENT TO HELP US TO GET JOBS BACK, TO GET FAMILIES BACK SECURE. THERE'S SO MUCH NEED. IT'S ALMOST LIKE A COVID EXPERIENCE, WHICH WE ALL REMEMBER, EXCEPT THIS TIME, THE REST OF THE NATION IS NOT IN COVID. SO THE SUPPORT WE'RE GETTING IS UNIQUE, BECAUSE IT'S MAUI-CENTRIC, BUT SO NEEDED.\r\n\r\nSO I SUPPORT THIS BY FILING IT. I DID SPEAK TO DIRECTOR MAHI BEFORE THE MEETING, AND WAS AWARE OF THE ADDITIONAL MONEY THAT HTA IS DOING, AND WE REALLY APPRECIATE IT. IT WILL BE MANAGED. IT WILL NOT BE HELTER-SKELTER BECAUSE EVERYBODY UNDERSTANDS THE CHAOS WE'RE IN AND TAMARA AND MYSELF WILL BE AVAILABLE TO TALK TO PEOPLE, IF THEY WANT TO ABOUT WHAT STEPS FORWARD? I BELIEVE THAT THE MESSAGES ARE LOUD AND CLEAR. THANK YOU. >> ANYONE ELSE?\r\n\r\nIF NOT, ALL THOSE IN FAVOR OF THE MOTION TO FILE BILL 84 RAISE YOUR HAND, SAY AYE? >> AYE. >> NINE AYES, ZERO NOS. MOTION CARRIES. THIS BRINGS US TO THE END OF THE CALENDAR. MY LITTLE CHICKADEES. WE HAVE A SPECIAL MESSAGE FROM OUR SPIRITUAL ADVISOR PRO TEM KAMA.\r\n\r\n>> THANK YOU, CHAIR. SO THIS AFTERNOON, AND YOU KNOW, IT'S AT 11:30 ON THE UP CAMPUS ON THE GREAT LAWN, AND THE TITLE OF THE EVENT IS CALLED "KUPUNI OU O MAUI." MEANING EMBRACE BELOVED MAUI A STATEWIDE DAY LONG VIGIL BEGINNING TODAY. AND THEY ACTUALLY SAID OOLA KAKOU HAWAI'I. MAY OUR HAWAI'I HEAL AS ONE. SO THEY ARE INVITING PEOPLE TO COME TODAY TO THE UP CAMPUS AND A LOT OF KUMU AND FAITH LEADERS WILL BE THERE TO LIFT OUR COMMUNITY IN PRAYER. OFFER AT THE KA'ANAPALI GOLF COURSE IS AN ARRIVAL AND TRADITIONAL HEALING OF LOMI LOMI FOR PEOPLE THAT NEED NOT JUST SPIRITUAL HEALING, BUT PHYSICAL HEALING OF THEIR BODIES AND 5:00 P.M. THE PROGRAM STARTS THERE. THEY JUST WANT PEOPLE TO COME, AND JUST TO LIFT UP ONE ANOTHER. ALSO, THEY ARE ASKING PEOPLE, IF YOU COULD HOLD VIGILS OF OUR OWN, IN OUR OWN HOME AND OWN FAMILIES WE CONTINUOUSLY DO THAT DAILY, BECAUSE IT'S SO IMPORTANT TO LIFT OF OUR COMMUNITY AND GIVE THEM HOPE.\r\n\r\nTHAT IS WHAT WE ARE HERE TO DO TODAY. SO THANK YOU, CHAIR. IF EVERYONE IS AVAILABLE AT 11:30 AT UP MAUI COLLEGE. >> MEMBER SUGIMURA. >> THANK YOU. IT'S BEAUTIFUL. I WANT TO LET MY COMMUNITY. WHICH IS UP COUNTRY. TOMORROW 9:00, 10:00, 12:00, ARE THE GATHERING TIMES VOLUNTEERS ARE GREEN WASTE DEBRIS REMOVAL FROM OUR GULCHES.\r\n\r\nI SEE THIS PHENOMENON HAPPENING AND THRILLED TO SEE THE FORCE OF THE COMMUNITY COME TOGETHER. SO AT KULA LODGE IS THE MEETING PLACE. AND THEY ARE ENERGIZED TO MAKE SURE THAT THIS DOESN'T HAPPEN AGAIN. THE MEETING --

THE GULCH AREA THAT THEY ARE WORKING ON WAS ONE OF THE FIRST FIRES THAT GOT IGNITED DURING THE UP COUNTRY WILDFIRE INCIDENT, AND IT IS SOMETHING THAT NOT ONLY ARE THEY FOCUSING ON THIS, BUT THERE'S A WHOLE OTHER GROUP AND COMMUNITY FOCUSING ON 6,000 ACRES OF LAND THAT BURNED PU'UELO AND THAT IT DOESN'T CREATE A MUDSLIDE TO MY NEIGHBOR MEMBER COOK'S COMMUNITY IN KIHEI AND THERE'S A WHOLE EFFORT ABOUT FIRE BREAKS AND HOW CATTLE -- THERE'S A WHOLE SCIENCE GOING ON. I VALUE THE SURFRIDER FOUNDATION, EVERYBODY WHO IS COMING TOGETHER, THE NRCS, THE SOIL WATER CONSERVATION DISTRICT AND THE GOVERNOR'S OFFICE AND TOGETHER, WE'LL MAKE STRIDES. EVERY DAY MAKES A DIFFERENCE. THANK YOU, MEMBERS.\r\n\r\n>> THANK YOU. MEMBER PALTIN. >> THANK YOU, CHAIR. I JUST WANTED TO SHARE I WAS ON A PANEL WITH ED SNIFFEN LAST NIGHT, AND HE WAS SAYING THAT THE STATE DEPARTMENT OF TRANSPORTATION WAS GOING TO START TO BE PROACTIVE ABOUT THOSE -- ABOUT BRUSH ABATEMENT AS WELL. SO I THINK THAT IS THE CHANGE THAT WE NEED TO SEE. AND JUST ENCOURAGE ANY LANDOWNER TO FOCUS ON BRUSH ABATEMENT, BECAUSE IT'S THE FUELS, YOU KNOW, THAT -- IT'S THE FUELS THAT DRIVE THE FIRES. THE FUEL ISN'T THERE, THERE WOULDN'T BE SO MUCH FIRE. SO IF THE COUNTY COULD FOLLOW SUIT ON THEIR LANDS, THAT WOULD BE A BIG PREVENTION MEASURE AS WELL.\r\n\r\n>> YES, WHOSE COMMITTEE WOULD THAT BE IN? YOURS? RIGHT? FIRE. MEMBER JOHNSON. >> THANK YOU, CHAIR. I JUST WANTED TO UPDATE EVERYONE FOR THE RECORD, AND THE COMMUNITY ABOUT THE UPDATED BUS ROUTES.\r\n\r\nSO THE MAUI BUS WILL IMPLEMENT A NEW WEST MAUI EXPRESS ROUTE NO. 29, AND THAT STARTED THURSDAY AUGUST 24TH, 2023. THE NEW BUS ROUTE COMBINES LAHAINA ISLANDER, NO. 20 AND WEST MAUI ISLANDER HE, WHICH IS 28. SO YOU MODIFICATIONS WITH HOURLY SERVICE FROM KAPALUA TO KA'ANAPALI TO THE KA'AHUMANU THROUGH KA'ANAPALI TO KAPALUA, 35:00 A.M. RUNNING DAILY AND SUBJECT TO CHANGE. THAT IS STRAIGHT OFF THE WEBSITE, JUST TO BE CLEAR WITH THAT. THANK YOU, CHAIR. >> THANK YOU. ANY OTHER COMMENTS OR ANNOUNCEMENTS?\r\nNO? OKAY.
