

ADOPTING THE WEIGHT TAX RATES
FOR THE COUNTY OF MAUI,
EFFECTIVE JANUARY 1, 2023

BE IT RESOLVED by the Council of the County of Maui:

1. That in accordance with Section 249-13 of the Hawaii Revised Statutes and Section 3.24.030 of the Maui County Code, the weight tax rates, effective January 1, 2023, are set as follows:

HIGHWAY FUND

Tax Rate

\$0.035 per pound of net weight for passenger vehicles, and trucks and noncommercial vehicles not exceeding 6,500 pounds.

\$0.0541 per pound of net weight for all other motor vehicles.

Minimum tax for any motor vehicle \$15.

Penalty for delinquent tax \$8 passenger vehicles
or \$20 other vehicles.

2. That certified copies of this Resolution be transmitted to the Mayor, County of Maui; the Director of Finance, County of Maui; the Budget Director, County of Maui; and the Director of Taxation, State of Hawaii.






