SUBJECT: BILL 132 (2025), AMENDING ORDINANCE 3889 (2011), RELATING TO CHANGE IN ZONING (CONDITIONAL ZONING) FOR WEST MAUI PROJECT DISTRICT 5 (PULELEHUA) FOR PROPERTY SITUATED AT LAHAINA, HAWAI'I (DRIP-17)

The Council's Disaster Recovery, International Affairs, and Planning Committee intends to consider Bill 132 (2025) at its meeting of November 5, 2025, at 9:00 a.m.

In County Communication 179-25, dated September 9, 2025, you noted that the Maui Planning Commission recommended approval of repealing Condition 2 of Ordinance 3889. However, in reviewing the Maui Planning Commission's minutes of its December 10, 2024, meeting, it appears that the Commission recommended that Condition 2 be amended, rather than repealed.

May I please request you clarify and confirm that the Maui Planning Commission amended, rather than repealed, Condition 2 of Ordinance 3889.

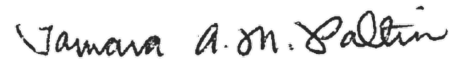
