

AUTHORIZING THE TRANSFER OF AN UNENCUMBERED  
APPROPRIATION BALANCE WITHIN THE  
DEPARTMENT OF FIRE AND PUBLIC SAFETY,  
FISCAL YEAR 2018 BUDGET

WHEREAS, Section 9-10(2) of the Revised Charter of the County of Maui (1983), as amended ("Charter"), provides that, upon written request of the Mayor, part or all of any unencumbered appropriation balance may be transferred within a department by resolution or from one department to another by ordinance; and

WHEREAS, Section 7 of the General Budget Provisions in Ordinance No. 4456, Bill No. 65 (2017), Draft 1, as amended, ("Fiscal Year 2018 Budget"), states that, unless otherwise provided, appropriations for each program may be disbursed for the following categories of use: (a) salaries, premium pay, or reallocation pay, (b) operations or services, and (c) equipment; provided the disbursement is within the program and category of use for which it was appropriated; and

WHEREAS, Section 3.B.5. of the Fiscal Year 2018 Budget, relating to the Department of Fire and Public Safety, sets forth appropriations for the Training Program and Fire/Rescue Operations Program; and

WHEREAS, pursuant to Section 9-10(2) of the Charter, Mayor Alan M. Arakawa has submitted a written request to transfer an unencumbered appropriation balance of \$40,480 from the Training Program, Category B<sub>1</sub> <sup>(operations)</sup> to the Training Program, Category C<sub>1</sub> <sup>(equipment)</sup> and \$12,200 from the Fire/Rescue Operations



Program, Category B<sub>1</sub><sup>(operations)</sup> to the Fire/Rescue Operations Program, Category C<sub>1</sub><sup>(equipment)</sup> in order to disburse \$52,680 for equipment from the appropriate category; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That, pursuant to Section 9-10(2) of the Charter and Section 7 of the General Budget Provisions, and in accordance with the Fiscal Year 2018 Budget, it does hereby authorize the transfer of an unencumbered appropriation balance of \$40,480 from the Training Program, Category B<sub>1</sub><sup>(operations)</sup> to the Training Program, Category C<sub>1</sub><sup>(equipment)</sup> and \$12,200 from the Fire/Rescue Operations Program, Category B<sub>1</sub><sup>(operations)</sup> to the Fire/Rescue Operations Program, Category C<sub>1</sub><sup>(equipment)</sup> for equipment; and
2. That certified copies of this resolution be transmitted to the Mayor,<sup>(turnouts, rescue saws, and rescue nets)</sup> Director of Finance, Budget Director, and <sup>Fire</sup> Chief of ~~Fire and Public Safety~~.
