







- Safe access and use for emergency responders, public, and contractors (vehicular and pedestrian traffic)
- Protection of private property

If Not Funded this FY:

- Potential threats to public health and safety
- Potential theft of property
- Potential damage to property

Debris Removal Update

- USACE Phase 1 - Completed
 - Conducted Hazardous Site Assessment.
 - Removed all hazardous materials.
- USACE Phase 2 - Ongoing
 - 120 residential properties cleared in Lahaina
 - Commercial properties starting March 2024
 - Estimated completion date summer 2025
- Permanent Disposal Site Survey completed



FEMA Direct Lease Program

Approx. 1100 units

Provide temporary housing for FEMA eligible displaced wildfire survivors

Initial Est. \$15 M loss of County RPT revenue for Start of Long Term Rental Exemption

Owners of Short-Term Rental Properties: Rental Properties Wanted



FEMA is actively seeking owners of rental units suitable for families and individuals displaced by the Maui wildfires. The units are offered to survivors for long-term leasing for up to 24 months.

FEMA's Direct Lease program is different from FEMA Rental Assistance that is maxed at the 175% FMR and different from the Non-Congregate Sheltering (NCS) program managed by the American Red Cross.


Through FEMA's Direct Lease program, you can help house a family in need and receive fair and stable compensation for doing so.

FEMA leases existing, ready-to-occupy residential properties for use as temporary housing for families displaced by the fires. Eligible properties may include single-family homes, multi-family homes, apartments, cooperatives, condominiums and townhouses. Property owners enter a contract with FEMA's property management company, not the tenant(s).







Permanent Housing Projects Pipeline
