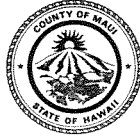

May I please request you attend the meeting and be prepared to respond to the following:


1. What is the Westside Shelter's current occupancy? If there are vacancies, please explain why and what is being done to fill these units.

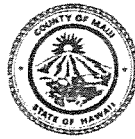
