GENERAL EXCISE TAX FUND - DEPARTMENT OF HAWAIIAN HOME **LANDS (BFED-21(13))**

The fund would be used for projects that directly support Department of Hawaiian Home Lands homestead The Committee's discussion may include Bill 111 (2023). development. entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 3.100, MAUI COUNTY CODE, RELATING TO GENERAL EXCISE AND USE TAX SURCHARGE." Bill 111 (2023) passed first reading at the Council's meeting of November 3, 2023, and remains with the Council for consideration of passage on second and final reading.
