**SUBJECT: AMENDMENTS TO THE FISCAL YEAR 2025 BUDGET  
(ESTIMATED REVENUES; DEPARTMENT OF FINANCE,  
COUNTYWIDE COSTS)**

I am transmitting a proposed bill, entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2025 BUDGET FOR THE COUNTY OF MAUI, ESTIMATED REVENUES; DEPARTMENT OF FINANCE, COUNTYWIDE COSTS, REIMBURSEMENT TO THE GENERAL FUND FOR PROJECTS DISQUALIFIED FROM TAX-EXEMPT BOND ISSUANCE."

The purpose of the proposed bill is to amend the Fiscal Year 2025 Budget to increase Carryover/Savings in the General Fund and Total Estimated Revenues in the amount of \$5,790,476, add a new appropriation to Department of Finance, Countywide Costs, entitled "Reimbursement to the General Fund for Projects Disqualified from Tax-Exempt Bond Issuance" in the amount of

\$5,790,476, and increase both Total Operating Appropriations and Total Appropriations by \$5,790,476.

The projects disqualified from tax exempt bond issuance are:

- OCS Office Renovations - \$820,045
- One Dozer for Hana Landfill - \$626,774
- Backhoe Loader - \$286,099
- Maui County Service Center - \$58,609
- Kahana Nui Bridge Replacement - \$210,900
- Waiale Road Drainage Improvements - \$146,539
- Countywide Drainline Replacement - \$127,262
- Wailuku Civic Hub - \$3,514,248
